R5, L2 2lr1694 HB 1132/20 - ENT CF 2lr3318 By: Delegates Mautz and Adams Introduced and read first time: February 11, 2022 Assigned to: Environment and Transportation Committee Report: Favorable with amendments House action: Adopted Read second time: March 14, 2022 CHAPTER AN ACT concerning Talbot County - Speed Monitoring Systems - Intersection of Maryland Route 333 (Oxford Road) and Bonfield Avenue FOR the purpose of authorizing the placement and use of a speed monitoring system at the intersection of Maryland Route 333 (Oxford Road) and Bonfield Avenue in Talbot County, subject to placement and signage requirements; requiring the fines collected by the Town of Oxford as a result of violations enforced by a speed monitoring system to be used to assist in covering the cost of roadway and pedestrian safety improvements in and around the intersection of Maryland Route 333 (Oxford Road) and Bonfield Avenue; requiring a certain real-time display of a driver's traveling speed for a speed monitoring system operating at the intersection of Maryland Route 333 (Oxford Road) and Bonfield Avenue; and generally relating to the placement and use of a speed monitoring system in Talbot County. - 1 (b) (1) A speed monitoring system may not be used in a local jurisdiction (i) 2 under this section unless its use is authorized by the governing body of the local jurisdiction 3 by local law enacted after reasonable notice and a public hearing. 4 (v) An ordinance or resolution adopted by the governing body of a local jurisdiction under this paragraph shall provide that, if the local jurisdiction moves or 5 places a mobile or stationary speed monitoring system to or at a location where a speed 6 7 monitoring system had not previously been moved or placed, the local jurisdiction may not 8 issue a citation for a violation recorded by that speed monitoring system: 9 1. Until signage is installed in accordance with 10 subparagraph (viii) of this paragraph; and 2. 11 For at least the first 15 calendar days after the signage is 12 installed. 13 (vi) This section applies to a violation of this subtitle recorded by a 14 speed monitoring system that meets the requirements of this subsection and has been 15 placed: 16 In Montgomery County or Prince George's County, on a 1. 17 highway in a residential district, as defined in § 21–101 of this title, with a maximum posted speed limit of 35 miles per hour, which speed limit was established using generally accepted 18 19 traffic engineering practices: 20 2. 9 10 11 12	(c) (1) Unless the driver of the motor vehicle received a citation from a police officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is recorded by a speed monitoring system while being operated in violation of this subtitle.
13	(2) A civil penalty under this subsection may not exceed \$40.
14	(3) For purposes of this section, the District Court shall prescribe:
15 16	(i) A uniform citation form consistent with subsection (d)(1) of this section and \S 7–302 of the Courts Article; and
17 18	(ii) A civil penalty, which shall be indicated on the citation, to be paid by persons who choose to prepay the civil penalty without appearing in District Court.
19 20 21 22	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2022. It shall remain effective for a period of 5 years and, at the end of September 30, 2027, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
