2 Coal Ash – Use, Recycling, and Management 3 (Coal Ash Recycling Act of 2022)

4 FOR the purpose of requiring that certain materials used in the State include coal ash as 5 a component of the material; requiring certain offshore wind projects to give 6 preference to certain cement materials beginning on a certain date; requiring all 7 contractors licensed in the State to use and give preference to materials that include 8 coal ash; requiring any person using materials in the State that include coal ash to 9 give preference to certain materials, hire local employees for certain work, and submit certain information to the Department of the Environment; requiring the 10 11 Department of the Environment to develop a certain tracking system; requiring the 12 Department of the Environment and the University System of Maryland jointly to 13 identify and make recommendations on certain opportunities and funding sources; requiring the Department of General Services, in coordination with the Department 14 of the Environment, to oversee the construction, operation, and maintenance of a 15 16 coal ash disposal and recycling facility in the State; and generally relating to the use, 17 recycling, and management of coal ash in the State.

28 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 1 DEPARTMENT FOR THE TRACKING SYSTEM DEVELOPED UNDER SUBSECTION (F) OF 2 THIS SECTION. 3 **(F) (1)** THE DEPARTMENT SHALL DEVELOP A SYSTEM FOR TRACKING: THE AMOUNT OF COAL ASH USED FOR THE PROTECTION 4 (I)5 AND STABILIZATION OF SHORELINES IN THE STATE; AND 6 (II)THE USE AND MANAGEMENT OF COAL ASH IN THE STATE. THE DEPARTMENT SHALL REQUEST FROM A PERSON USING 7 8 MATERIALS IN THE STATE THAT INCLUDE COAL ASH ANY INFORMATION NECESSARY FOR THE DEVELOPMENT AND USE OF THE TRACKING SYSTEM. 9 10 (G) **(1)** THE DEPARTMENT AND THE UNIVERSITY SYSTEM OF MARYLAND 11 JOINTLY SHALL IDENTIFY AND MAKE RECOMMENDATIONS ON: **(I)** 12 OPPORTUNITIES FOR THE USE OF COAL ASH IN THE STATE; 13 AND 14 FUNDING SOURCES TO PROMOTE AND INCREASE THE USE OF COAL ASH IN THE STATE. 15 16 ON OR BEFORE DECEMBER 1, 2022, THE DEPARTMENT AND THE University System of Maryland Jointly shall report on their findings 17 AND RECOMMENDATIONS TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 18 19 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY. **Article - State Finance and Procurement** 20 21SUBTITLE 12.
