





- 3 BE REINVESTED IN THE LOCAL COMMUNITY WHERE THE FACILITY OR STORE
- 4 OPERATES.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 2022.
