- 4 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS 5 INDICATED.
- 6 (B) "ALTERNATIVE THERAPIES" INCLUDES HYPERBARIC OXYGEN THERAPY
 7 AND PSYCHEDELICS INCLUDING 3,4-METHYLENEDIOXYMETHAMPHETAMINE

- 10 (3) ANY USES DETERMINED BY THE DEPARTMENT UNDER 11 SUBSECTION (I) OF THIS SECTION; AND
- 12 (4) ADMINISTRATIVE EXPENSES OF THE DEPARTMENT IN 13 ADMINISTERING THE FUND.

SECTION 2. AND BE IT FURTHER ENACTED, That for fiscal year 2024, the Governor shall include in the annual budget bill an appropriation in an amount of \$1,000,000 to the Post–Traumatic Stress Disorder and Traumatic Brain Injury Alternative Therapies Fund established under § 24–1802 of the Health – General Article, as enacted by Section 1 of this Act.			
SECTION 3. AND BE IT FURTHER ENACTED, That the Maryland Department of Health shall report to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly:			
(1) on or before December 1, 2022, its initial findings and recommendation under § 24–1802(i) of the Health – General Article, as enacted by Section 1 of this Act; and			
(2) on or before December 1, 2024, findings and recommendations from studies funded by the Post–Traumatic Stress Disorder <u>and Traumatic Brain Injury</u> Alternative Therapies Fund established under § 24–1802 of the Health – General Article as enacted by Section 1 of this Act, including:			
(i) any findings regarding the efficacy of alternative therapies as treatment for post-traumatic stress disorder <u>and traumatic brain injuries</u> ; and			
(ii) recommendations on budgetary, legislative, or regulatory changes to expand access to alternative therapies for veterans with post–traumatic stress disorder <u>and traumatic brain injuries</u> .			
SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022.
