3 FOR the purpose of prohibiting a social media website from taking certain actions to censor the religious speech or political speech of a certain user; providing that the owner or 4 5 operator of a social media website is subject to a certain cause of action for taking 6 certain actions to censor the religious speech or political speech of a certain user; 7 authorizing the Attorney General to bring a certain civil cause of action; providing 8 that a violation of this Act is an unfair, abusive, or deceptive trade practice that is subject to certain penalties; requiring a social media website to publish certain rules 9 and policies and provide certain notice related to the ban or suspension of a user; 10 11 requiring the Secretary of State to impose certain fines on a social media website 12 under certain circumstances; prohibiting a social media website from using a certain 13 user's alleged hate speech for a certain purpose; and generally relating to social 14 media websites and censored speech.


