A BILL ENTITLED

1 AN ACT concerning

2 **Employees – Department of State Police – Emergency Dispatcher Classification**

3 FOR the purpose of requiring the Department of State Police to establish certain emergency
4 dispatcher classifications; establishing certain compensation levels and employment
5 requirements for emergency dispatcher classifications; and generally relating to the
6 Department of State Police and emergency dispatcher classifications.

7 BY adding to

10 Annotated Code of Maryland

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 **2–419.**

16 **(A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE DEPARTMENT**
17 **SHALL ESTABLISH THE FOLLOWING CLASSIFICATIONS WITHIN THE**
18 **COMMUNICATIONS DIVISION OF THE DEPARTMENT:**

19 **(1) EMERGENCY DISPATCHER TRAINEE;**

20 **(2) EMERGENCY DISPATCHER I;**

21 **(3) EMERGENCY DISPATCHER II;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 **(4) EMERGENCY DISPATCHER III;**
2 **(5) EMERGENCY DISPATCHER SENIOR;**
3 **(6) EMERGENCY DISPATCHER SUPERVISOR; AND**
4 **(7) EMERGENCY DISPATCHER SUPERVISOR SENIOR.**

5 **(B) EACH EMERGENCY DISPATCHER CLASSIFICATION SHALL RECEIVE THE**
6 **HIGHER AMOUNT OF THE FOLLOWING MINIMUM LEVELS OF COMPENSATION:**

7 **(1) (I) FOR EMERGENCY DISPATCHER TRAINEE, WITH NO**
8 **TENURE, SALARIES SHALL BE SET AT A RATE NOT LESS THAN GRADE 12, STEP 4 OF**
9 **THE STATE PAY SCALE OR A MINIMUM OF \$43,136;**

10 **(II) FOR EMERGENCY DISPATCHER I, WITH UP TO 4 YEARS OF**
11 **TENURE INCLUDING TRAINING, SALARIES SHALL BE SET AT A RATE NOT LESS THAN**
12 **GRADE 14, STEP 4 OF THE STATE PAY SCALE OR A RANGE OF \$48,843 TO \$67,106;**

13 **(III) FOR EMERGENCY DISPATCHER II, WITH 5 TO 9 YEARS OF**
14 **TENURE, SALARIES SHALL BE SET AT A RATE NOT LESS THAN GRADE 15, STEP 5 OF**
15 **THE STATE PAY SCALE OR A RANGE OF \$53,935 TO \$71,606;**

16 **(IV) FOR EMERGENCY DISPATCHER III, WITH 10 TO 14 YEARS**
17 **OF TENURE, SALARIES SHALL BE SET AT A RATE NOT LESS THAN GRADE 16, STEP 10**
18 **OF THE STATE PAY SCALE OR A RANGE OF \$63,191 TO \$76,432;**

19 **(V) FOR EMERGENCY DISPATCHER SENIOR, WITH A MINIMUM**
20 **OF 15 YEARS OF TENURE, SALARIES SHALL BE SET AT A RATE NOT LESS THAN GRADE**
21 **17, STEP 15 OF THE STATE PAY SCALE OR A MAXIMUM OF \$81,596;**

22 **(VI) FOR EMERGENCY DISPATCHER SUPERVISOR, WITH 5 TO 9**
23 **YEARS OF SUPERVISORY TENURE, SALARIES SHALL BE SET AT A RATE NOT LESS**
24 **THAN GRADE 18, STEP 5 OF THE STATE PAY SCALE OR A RANGE OF \$63,014 TO**
25 **\$87,106; AND**

26 **(VII) FOR EMERGENCY DISPATCHER SUPERVISOR SENIOR, WITH**
27 **A MINIMUM OF 10 YEARS OF SUPERVISORY TENURE, SALARIES SHALL BE SET AT A**
28 **RATE NOT LESS THAN GRADE 19, STEP 10 OF THE STATE PAY SCALE OR A RANGE OF**
29 **\$75,605 TO \$92,897; OR**

30 **(2) THE PAY SCALE PROVIDED IN THE STATE BUDGET FOR EACH**
31 **POSITION.**

1 **(C) EACH EMERGENCY DISPATCHER APPLICANT SHALL:**

2 **(1) SUCCESSFULLY COMPLETE A BACKGROUND INVESTIGATION**
3 **CONDUCTED BY THE DEPARTMENT; AND**

4 **(2) ON HIRE, COMPLETE SUBSTANCE ABUSE TESTING IN**
5 **ACCORDANCE WITH COMAR 17.04.09.**

6 **(D) AT ANY TIME, THE SECRETARY MAY ALTER THE ESSENTIAL JOB**
7 **FUNCTIONS OF EACH EMERGENCY DISPATCHER POSITION.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That on or before January 1, 2023,
9 all Communications Operator positions of any rank or seniority within the Department in
10 existence before January 1, 2023, including trainees, shall be reclassified in accordance
11 with Section 1 of this Act.

12 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2022.
