2 **Maggie McIntosh School Arts Fund – Established**

3 FOR the purpose of establishing the Maggie McIntosh School Arts Fund as a special,
4 nonlapsing fund; requiring interest earnings of the Fund to be credited to the Fund;
5 altering the allocation of revenues from the State Lottery Fund after a certain date;
6 and generally relating to the Maggie McIntosh School Arts Fund.

~~(iii) "Eligible school" does not include a school that is eligible to receive funding under this section but has closed.~~

(A) IN THIS SECTION, "FUND" MEANS THE MAGGIE MCINTOSH SCHOOL ARTS FUND.

(B) THERE IS A MAGGIE MCINTOSH SCHOOL ARTS FUND.

(C) THE PURPOSE OF THE FUND IS TO PROVIDE GRANTS TO PUBLIC SCHOOLS IN BALTIMORE CITY TO PURCHASE ART SUPPLIES FOR CLASSROOMS.

(D) ARTS ~~EVERYDAY~~ EVERY DAY SHALL ADMINISTER THE FUND.

(E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

1 **(2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,**
2 **AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

3 **(F) THE FUND CONSISTS OF:**

4 **(1) REVENUE DISTRIBUTED TO THE FUND UNDER § 9-120(B)(1)(VIII)**
5 **OF THE STATE GOVERNMENT ARTICLE;**

6 **(2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;**

7 **(3) INTEREST EARNINGS OR OTHER INCOME EARNED FROM THE**
8 **INVESTMENT OF ANY MONEY FROM THE FUND; AND**

9 **(4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
10 **THE BENEFIT OF THE FUND.**

11 **(G) THE FUND SHALL BE USED TO EXPAND THE ARTS CURRICULUM FOR**
12 **STUDENTS IN ~~ELIGIBLE PUBLIC SCHOOLS UNDER THE CONCENTRATION OF~~**
13 **~~POVERTY GRANT PROGRAM~~ PUBLIC SCHOOLS IN BALTIMORE CITY, AS DEFINED IN**

10 deposit, cause to be deposited, or pay:

11 (i) into the Maryland Stadium Facilities Fund established under §
12 7–312 of the State Finance and Procurement Article from the money that remains in the
13 State Lottery Fund, after the distribution under subsection (a) of this section, an amount
14 not to exceed \$20,000,000 in any fiscal year;

15 (ii) after June 30, 2014, into the Maryland Veterans Trust Fund 10%
16 of the money that remains in the State Lottery Fund from the proceeds of sales of tickets
17 from instant ticket lottery machines by veterans' organizations under § 9–112(d) of this
18 subtitle, after the distribution under subsection (a) of this section;

19 (iii) after June 30, 2014, into the Baltimore City Public School
20 Construction Financing Fund established under § 10–656 of the Economic Development
21 Article the money that remains in the State Lottery Fund from the proceeds of all lotteries
22 after the distributions under subsection (a) of this section and items (i) and (ii) of this
23 paragraph, an amount equal to \$20,000,000 in each fiscal year that bonds are outstanding
24 and unpaid, to be paid in two installments with at least \$10,000,000 paid no later than
25 December 1 of each fiscal year;

26 (iv) after June 30, 2021, into the Racing and Community
27 Development Financing Fund established under § 10–657.2 of the Economic Development
28 Article from the money that remains in the State Lottery Fund, after the distribution under
29 subsection (a) of this section, an amount equal to \$17,000,000 in each fiscal year until the
30 bonds issued for a racing facility have matured;

31 (v) after June 30, 2020, into the Michael Erin Busch Sports Fund
32 established under § 10–612.2 of the Economic Development Article from the money that
33 remains in the State Lottery Fund from the proceeds of all lotteries after the distributions

2 equal to \$1,000,000 in each fiscal year;

3 (vi) after June 30, 2021, a grant to the Maryland Humanities Council

6 through (v) of this paragraph, an amount equal to \$150,000 in each fiscal year;

12 ARTICLE FROM THE MONEY THAT REMAINS IN THE STATE LOTTERY FUND FROM
