The notice required under this section shall be given in person or by

certified mail, return receipt requested, bearing a postmark from the United States Postal

1 Service, by the claimant or the representative of the claimant. 2 Except as otherwise provided, if the defendant local government is a 3 county, the notice required under this section shall be given to the county commissioners or county council of the defendant local government. 4 5 (3) If the defendant local government is: 6 (i) Baltimore City, the notice shall be given to the City Solicitor; 7 (ii) Howard County or Montgomery County, the notice shall be given to the County Executive; and 8 9 Anne Arundel County, Baltimore County, Frederick County, (iii) Harford County, or Prince George's County, the notice shall be given to the county solicitor 10 11 or county attorney. 12 **(4)** For any other local government, the notice shall be given to the 13 corporate authorities of the defendant local government. Notwithstanding the other provisions of this section, unless the defendant can 14 (d) 15 affirmatively show that its defense has been prejudiced by lack of required notice, upon 16 motion and for good cause shown the court may entertain the suit even though the required 17 notice was not given. 18 This section does not apply if, within 1 year after the injury, the defendant 19 local government has actual or constructive notice of: 20 (1) The claimant's injury; or 21(2) The defect or circumstances giving rise to the claimant's injury. 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to 23apply only prospectively and may not be applied or interpreted to have any effect on or application to any cause of action arising before the effective date of this Act. 2425SECTION 3.
