BY repealing and reenacting, with amendments, Article – Health Occupations Section 12–101(o–1) Annotated Code of Maryland (2021 Replacement Volume) BY repealing and reenacting, without amendments, Article – Health Occupations Section 12-509(a) and (b) Annotated Code of Maryland (2021 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

11 12 13	(a) In addition to the authority granted to a pharmacist under § 12–508 of this subtitle, a pharmacist, in accordance with regulations adopted by the Board, may administer:
14 15	(1) A self-administered drug to a patient that is prescribed by an authorized prescriber; and
16 17	(2) Subject to subsection (b) of this section, a maintenance injectable medication that is not a biological product to a patient:
18	(i) That is prescribed by an authorized prescriber;
19 20	(ii) In accordance with a standing order issued by an authorized public health official; or
21	(iii) In accordance with a protocol under Subtitle 6A of this title.
22 23 24	(b) A pharmacist may not administer an initial dose of a maintenance injectable medication product under subsection (a)(2) of this section unless the pharmacist receives written approval from the prescriber.
