## A BILL ENTITLED

1 AN ACT concerning

2 **Crimes – Unattended Dogs – Extreme Weather Conditions and Heat**

3 FOR the purpose of prohibiting a person from leaving a dog outside and unattended for  
4 longer than a certain period without access to certain suitable shelter or suitable  
5 shade during certain weather conditions or temperatures, subject to certain  
6 exceptions; and generally relating to leaving unattended dogs outside.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Criminal Law**

15 10–623.

16 (a) (1) In this section the following words have the meanings indicated.

17 (2) “Collar” means a device constructed of nylon, leather, or similar  
18 material specifically designed to be used around the neck of a dog.

19 **(3) (I) “EXTREME WEATHER CONDITIONS” MEANS**  
20 **TEMPERATURES BELOW 32 DEGREES FAHRENHEIT OR CONDITIONS DURING AN**  
21 **ACTIVE WEATHER WARNING OR ADVISORY ISSUED BY THE NATIONAL WEATHER**  
22 **SERVICE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (II) "EXTREME WEATHER CONDITIONS" DOES NOT INCLUDE  
2 MARINE WARNINGS OR ADVISORIES ISSUED BY THE NATIONAL WEATHER SERVICE.

3 [(3)] (4) "Restraint" means a chain, rope, tether, leash, cable, or other  
4 device that attaches a dog to a stationary object or trolley system.

5 (5) "SPORTING" MEANS ANY ATHLETIC COMPETITION, SKILL  
6 COMPETITION, OBEDIENCE COMPETITION, OR OTHER COMPETITION INTENDED FOR  
7 THE PARTICIPATION OF DOGS.

8 (6) "SUITABLE SHADE" MEANS AN AREA COMPLETELY PROTECTED  
9 FROM THE DIRECT SUN THAT IS ACCESSIBLE AND FULLY COVERS A DOG.

10 (7) (I) "SUITABLE SHELTER" MEANS A STRUCTURE THAT:

11 1. IS PROPERLY VENTILATED;

12 2. HAS A SOLID FLOOR THAT IS RAISED OFF THE GROUND  
13 OR A SOLID FLOOR THAT IS PROPERLY INSULATED;

14 3. HAS A WEATHERPROOF ROOF;

15 4. HAS FOUR WALLS, ONE OF WHICH CONTAINS A  
16 DOORWAY;

17 5. HAS INSULATION TO ALLOW A DOG TO MAINTAIN ITS  
18 NORMAL BODY TEMPERATURE; AND

19 6. IS SUITABLE FOR THE SPECIES, AGE, CONDITION,  
20 SIZE, AND TYPE OF DOG.

21 (II) "SUITABLE SHELTER" DOES NOT INCLUDE:

22 1. A CRAWL SPACE THAT IS UNDER A BUILDING OR PART  
23 OF A BUILDING;

24 2. THE SPACE UNDER A VEHICLE;

25 3. A FLOOR CONSISTING OF WIRE OR CHAIN LINK; OR

26 4. A STRUCTURE MADE FROM CARDBOARD OR OTHER  
27 MATERIALS THAT ARE EASILY DEGRADED BY THE ELEMENTS.

28 (b) A person may not leave a dog outside and unattended by use of a restraint:

- 1 (1) that unreasonably limits the movement of the dog;
- 2 (2) that uses a collar that:
- 3 (i) is made primarily of metal; or
- 4 (ii) is not at least as large as the circumference of the dog's neck plus  
5 1 inch;
- 6 (3) that restricts the access of the dog to suitable and sufficient clean water  
7 or appropriate shelter;
- 8 (4) in unsafe or unsanitary conditions; or
- 9 (5) that causes injury to the dog.

10 **(C) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, A PERSON**  
11 **MAY NOT LEAVE A DOG OUTSIDE AND UNATTENDED FOR LONGER THAN 30 MINUTES**  
12 **WITHOUT ACCESS TO CONTINUOUS:**

13 **(1) SUITABLE SHELTER DURING EXTREME WEATHER CONDITIONS;**  
14 **AND**

15 **(2) SUITABLE SHELTER OR SUITABLE SHADE WHEN TEMPERATURES**  
16 **ARE ABOVE 90 DEGREES FAHRENHEIT BUT BELOW WHAT IS REQUIRED FOR A HEAT**  
17 **ADVISORY.**

18 **(D) THE PROHIBITION IN SUBSECTION (C) OF THIS SECTION DOES NOT**  
19 **APPLY IF THE DOG IS LAWFULLY AND ACTIVELY ENGAGED IN:**

- 20 **(1) HUNTING;**
- 21 **(2) LIVESTOCK HERDING OR GUARDING;**
- 22 **(3) SLEDDING;**
- 23 **(4) SPORTING; OR**
- 24 **(5) TRAINING.**

25 **[(c)] (E) (1) A person who violates SUBSECTION (B) OF this section is guilty**  
26 **of a misdemeanor and on conviction is subject to imprisonment not exceeding 90 days or a**  
27 **fine not exceeding \$1,000 or both.**

1                   **(2) A VIOLATION OF SUBSECTION (C) OF THIS SECTION IS A CIVIL**  
2 **OFFENSE PUNISHABLE BY:**

3                   **(I) FOR A FIRST VIOLATION, A WARNING;**

4                   **(II) FOR A SECOND VIOLATION, A CIVIL PENALTY OF UP TO \$500;**  
5 **AND**

6                   **(III) FOR A THIRD OR SUBSEQUENT VIOLATION, A CIVIL PENALTY**  
7 **OF UP TO \$1,000.**

8                   **(F) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A LOCAL**  
9 **GOVERNMENT FROM ADOPTING A REQUIREMENT FOR THE HEALTH AND SAFETY OF**  
10 **DOGS THAT IS MORE STRINGENT THAN THE REQUIREMENTS OF THIS SECTION.**

11                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12 October 1, 2022.
