4 Secretary of Health to adopt regulations to implement a pediatric cancer research
5 grant program; ~~requiring the Comptroller to include a checkoff on individual income~~
6 ~~tax return forms for voluntary contributions to the Fund and to include certain~~
7 ~~information in each individual income tax return package; and generally relating to~~
8 the Maryland Pediatric Cancer Fund.

(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) “FUND” MEANS THE MARYLAND PEDIATRIC CANCER FUND ESTABLISHED UNDER THIS SECTION.

~~(3) “INCOME TAX CHECKOFF SYSTEM” MEANS THE CHECKOFF SYSTEM ESTABLISHED UNDER § 2-116 OF THE TAX – GENERAL ARTICLE.~~

~~(4)~~ (3) “PEDIATRIC CANCER RESEARCH” INCLUDES RESEARCH TO DEVELOP AND ADVANCE THE UNDERSTANDING OF PEDIATRIC CANCER AND THE TECHNIQUES AND MODALITIES EFFECTIVE IN THE PREVENTION, CURE, SCREENING, AND TREATMENT OF PEDIATRIC CANCER.

(B) (1) THERE IS A MARYLAND PEDIATRIC CANCER FUND.

~~(2) THE NET PROCEEDS FROM CONTRIBUTIONS UNDER THE INCOME TAX CHECKOFF SYSTEM AND ANY OTHER DONATIONS TO THE FUND SHALL BE CREDITED TO THE FUND.~~

(2) THE FUND CONSISTS OF:

(i) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND; AND

(ii) ANY DONATIONS OR OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR THE BENEFIT OF THE FUND.

(3) THE SECRETARY SHALL ADMINISTER THE FUND.

(4) THE FUND SHALL BE USED ONLY FOR PEDIATRIC CANCER RESEARCH, PREVENTION, AND TREATMENT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION.

1 **(5) THE FUND SHALL BE MAINTAINED FOR THE PURPOSES STATED IN**
2 **THIS SECTION AND UNSPENT PORTIONS OF THE FUND SHALL REMAIN IN THE FUND**
3 **AND MAY NOT REVERT TO THE GENERAL FUND OF THE STATE.**

4 **(6) MONEY EXPENDED FROM THE FUND FOR PEDIATRIC CANCER**
5 **RESEARCH, PREVENTION, AND TREATMENT IS SUPPLEMENTAL AND IS NOT**
6 **INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE**
7 **APPROPRIATED TO THE DEPARTMENT FOR PEDIATRIC CANCER RESEARCH,**
8 **PREVENTION, AND TREATMENT.**

9 **(7) ALL EXPENDITURES FROM THE FUND SHALL BE MADE ONLY IN**
10 **ACCORDANCE WITH AN APPROPRIATION APPROVED BY THE GENERAL ASSEMBLY IN**
11 **THE ANNUAL STATE BUDGET OR THROUGH AN APPROVED BUDGET AMENDMENT**
12 **UNDER §§ 7-209 AND 7-210 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

13 **(8) (I) FOR FISCAL YEAR 2023, THE GOVERNOR SHALL INCLUDE IN**
14 **THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$5,000,000 TO THE FUND.**

15 **(II) IF \$5,000,000 IS NOT INCLUDED IN THE ANNUAL BUDGET**
16 **BILL FOR FISCAL YEAR 2023, THEN THE GOVERNOR SHALL INCLUDE IN THE ANNUAL**
17 **BUDGET BILL FOR FISCAL YEAR 2024 AN APPROPRIATION OF \$5,000,000 TO THE**
18 **FUND.**

19 **(C) (1) ~~THE EACH YEAR, THE~~ SECRETARY MAY DISTRIBUTE NOT MORE**
20 **THAN 5% OF THE ~~NET PROCEEDS OF THE~~ FUND TO A PROMOTIONAL ACCOUNT TO BE**
21 **USED TO PROMOTE FURTHER DONATIONS TO THE FUND.**
