- 3 FOR the purpose of requiring the court in an action to partition real property to determine 4 whether the property is heirs property for the purpose of partition of the property 5 among certain cotenants and if so, to determine the market value of the property 6 unless the court makes certain determinations; establishing procedures for the 7 purchase of interests in heirs property by cotenants, for the partition in kind of heirs 8 property among cotenants, and for the partition by sale of heirs property on the open 9 market by a real estate broker licensed in this State; and generally relating to the 10 partition of heirs property.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 That the Laws of Maryland read as follows:

## 3 Article – Estates and Trusts

- 5 (a) (1) When two or more heirs or legatees are entitled to distribution of undivided interests in property of the estate, the personal representative or one or more of the heirs or legatees may petition the court before the formal or informal closing of the estate, to make partition.
- 9 (2) After notice to the interested heirs or legatees AND SUBJECT TO THE 10 REQUIREMENTS OF TITLE 14, SUBTITLE 7 OF THE REAL PROPERTY ARTICLE, the 11 court shall partition the property in the same manner as provided by law for civil actions 12 of partition.
- 13 (b) The court may direct the personal representative to sell property which cannot 14 be partitioned without prejudice to the owners and cannot conveniently be allotted to one 15 party.

- 18 (J) "RELATIVE" MEANS AN ASCENDANT, A DESCENDANT, OR A COLLATERAL
  19 OR AN INDIVIDUAL OTHERWISE RELATED TO ANOTHER INDIVIDUAL BY BLOOD,
  20 MARRIAGE, ADOPTION, OR LAW OF THIS STATE OTHER THAN THIS SUBTITLE.

- 10 PROMPTLY ISSUE AN ORDER REALLOCATING ALL OF
- 11 THE COTENANTS' INTERESTS, DISBURSE THE AMOUNTS HELD BY THE COURT TO THE
- 12 PERSONS ENTITLED TO THEM, AND REFUND ANY EXCESS PAYMENT HELD BY THE
- 13 COURT.
- 14 (G) NOT LATER THAN 45 DAYS AFTER THE COURT SENDS NOTICE TO THE
- 15 PARTIES UNDER SUBSECTION (A) OF THIS SECTION, ANY COTENANT ENTITLED TO
- 16 BUY AN INTEREST UNDER THIS SECTION MAY REQUEST THE COURT TO AUTHORIZE
- 17 THE SALE AS PART OF THE PENDING ACTION OF THE INTERESTS OF COTENANTS
- 18 NAMED AS DEFENDANTS AND SERVED WITH THE COMPLAINT BUT THAT DID NOT
- 19 APPEAR IN THE ACTION.
- 20 (H) IF THE COURT RECEIVES A TIMELY REQUEST UNDER SUBSECTION (G) OF
- 21 THIS SECTION, THE COURT, AFTER A HEARING, MAY DENY THE REQUEST OR

- 33 (A) (1) IF UNDER § 14–706 OF THIS SUBTITLE ALL THE INTERESTS OF ALL
- 34 COTENANTS THAT REQUESTED PARTITION BY SALE ARE NOT PURCHASED BY OTHER

- 1 COTENANTS, OR IF AFTER THE CONCLUSION OF THE BUYOUT A COTENANT REMAINS
- 2 THAT HAS REQUESTED PARTITION IN KIND, THE COURT SHALL ORDER PARTITION IN

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any partition action filed before the effective date of this Act.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2022.
