BY repealing and reenacting, with amendments, Article – Natural Resources Section 10–410(a) Annotated Code of Maryland (2012 Replacement Volume and 2021 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Natural Resources 10-410.**(1)** (a) (I)The Department may allow a person to hunt on each Sunday of the game bird and game mammal seasons in: Allegany County; <del>(i)</del> 1.

1 The Department may allow a person using a State certified raptor to 2 hunt game birds or mammals on each Sunday during the open season for the game birds 3 or mammals. 4 (9)The Department may allow an unarmed person participating in an 5 organized fox chase to chase foxes on Sunday. 6 The Department may allow a person shooting pen-reared game birds 7 or tower-released flighted mallard ducks to hunt on Sunday at a regulated shooting ground 8 in accordance with § 10-906 of this title. The Department may allow a person who is 16 years old or younger to 9 10 hunt on Sunday if participating in a junior hunt established by the Department in accordance with this subtitle. 11 12 Except as provided in paragraphs (8) through (10) of this subsection and 13 subject to paragraph (7) of this subsection, a person may not hunt on Sunday in: 14 (i) Baltimore City: 15 (ii) Baltimore County; 16 (iii) Howard County; or Prince George's County. 17 (iv) 18 (13)A person may not hunt migratory game birds on Sunday. 19 (14)A person may not hunt on public land within the State park system on 20 Sunday. 21The Department may not allow a person to hunt on public land (15)22designated for hunting by the Department on Sunday except in: 23 Allegany County; (i) 24 (ii) Cecil County; 25 (iii) Garrett County; 26 St. Mary's County; (iv) 27 Washington County; (v) 28 Dorchester County, for turkey during the spring turkey hunting (vi) 29 season; and

(vii) Frederick County, for deer from the first Sunday in October through the second Sunday in January of the following year, inclusive.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July $1,2022.$
