- 3 (E) THE SECRETARY SHALL ADOPT REGULATIONS TO IMPLEMENT THE 4 REQUIREMENTS OF THIS SECTION, INCLUDING REGULATIONS ESTABLISHING:
- 5 (1) APPLICATION AND APPROVAL PROCESSES; AND
- 6 (2) ELIGIBILITY STANDARDS.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2022.
