- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

18 EXCEPT FOR THE ISSUANCE OF LICENSES UNDER THIS TITLE OR THE 19 IMPOSITION OF TAXES ON CIGARETTES UNDER TITLE 12 OF THE TAX – GENERAL 20 ARTICLE, THE BALTIMORE CITY COUNCIL MAY ENACT AND THE MAYOR OF 21 BALTIMORE CITY MAY ENFORCE LOCAL LAWS THAT ARE AT LEAST AS STRINGENT AS 22 THE PROVISIONS OF THIS TITLE THAT REGULATE THE SALE AND DISTRIBUTION OF 23 CIGARETTES.

8 EXCEPT FOR THE ISSUANCE OF LICENSES UNDER THIS TITLE, THE 9 BALTIMORE CITY COUNCIL MAY ENACT AND THE MAYOR OF BALTIMORE CITY MAY 10 ENFORCE LOCAL LAWS THAT ARE AT LEAST AS STRINGENT AS THE PROVISIONS OF 11 THIS TITLE THAT REGULATE THE SALE AND DISTRIBUTION OF ELECTRONIC 12 SMOKING DEVICES.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 October 1, 2022.
