## A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Voter Registration Drive – High Schools**

3 FOR the purpose of requiring each local board of elections to conduct a voter registration  
4 drive at least once each school year in each public high school in the county in a  
5 manner specified in an agreement between the local board and county board of  
6 education; requiring each public official responsible for the use of a public high school  
7 to make available to the local board of elections, without charge, the space that is  
8 needed in the building for the proper conduct of a voter registration drive; and  
9 generally relating to voter registration drives conducted in public high schools.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

22 **Article – Election Law**

23 3–102.

24 (a) (1) Except as provided in subsection (b) of this section, an individual may  
25 become registered to vote if the individual:

- 1 (i) is a citizen of the United States;
- 2 (ii) is at least 16 years old;
- 3 (iii) is a resident of the State as of the day the individual seeks to  
4 register; and
- 5 (iv) registers pursuant to this title.

6 3–201.

- 7 (a) An individual may apply to become a registered voter:
- 8 (1) at a local board office or the State Board office;
- 9 (2) at a registration site administered by a local board;
- 10 (3) by mail;
- 11 (4) when applying to the Motor Vehicle Administration for the issuance,  
12 renewal, or modification of a driver’s license or identification card;
- 13 (5) when applying for services at a voter registration agency;
- 14 (6) through the State Board’s online voter registration system; or
- 15 (7) with the assistance of a volunteer authorized by the State or local board.
- 16 (b) An individual who is at least 18 years old or will be 18 years old on or before  
17 the day of the next succeeding general or special election may be a volunteer under  
18 subsection (a)(7) of this section.

20 **(A) (1) IN THIS SECTION, “VOTER REGISTRATION DRIVE” MEANS A VOTER**  
21 **REGISTRATION SITE ADMINISTERED BY A LOCAL BOARD WHERE VOTER**  
22 **REGISTRATION APPLICATIONS APPROVED BY THE STATE BOARD ARE DISTRIBUTED**  
23 **TO INDIVIDUALS ELIGIBLE TO REGISTER TO VOTE.**

24 **(2) “VOTER REGISTRATION DRIVE” MAY INCLUDE:**

25 **(I) AN EVENT ON SCHOOL PROPERTY, DURING SCHOOL HOURS,**  
26 **OPEN TO EACH EMPLOYEE OF AND STUDENT ENROLLED IN THE SCHOOL WHO IS OR**  
27 **WILL BE 16 YEARS OLD OR OLDER DURING THE IMMEDIATELY FOLLOWING YEAR,**  
28 **WHERE COMPLETED VOTER REGISTRATION APPLICATIONS ARE ACCEPTED BY A**

1 LOCAL BOARD OFFICIAL, EMPLOYEE, OR AUTHORIZED VOLUNTEER FOR  
2 TRANSMITTAL TO THE APPROPRIATE ELECTION OFFICIAL; OR

3 (II) LOCAL BOARD OFFICIALS, EMPLOYEES, OR AUTHORIZED  
4 VOLUNTEERS VISITING CLASSROOMS WITHIN A SCHOOL, DURING SCHOOL HOURS,  
5 DISTRIBUTING VOTER REGISTRATION APPLICATIONS TO EACH EMPLOYEE OF AND  
6 STUDENT ENROLLED IN THE SCHOOL WHO IS OR WILL BE 16 YEARS OLD OR OLDER  
7 DURING THE IMMEDIATELY FOLLOWING YEAR AND ACCEPTING COMPLETED VOTER  
8 REGISTRATION APPLICATIONS FOR TRANSMITTAL TO THE APPROPRIATE ELECTION  
9 OFFICIAL.

10 (B) AT LEAST ONCE EACH SCHOOL YEAR, EACH LOCAL BOARD SHALL  
11 CONDUCT A VOTER REGISTRATION DRIVE IN EACH PUBLIC HIGH SCHOOL IN THE  
12 COUNTY IN A MANNER SPECIFIED IN AN AGREEMENT BETWEEN THE LOCAL BOARD  
13 AND THE COUNTY BOARD OF EDUCATION.

14 (C) EACH PUBLIC OFFICIAL RESPONSIBLE FOR THE USE OF A PUBLIC HIGH  
15 SCHOOL SHALL MAKE AVAILABLE TO THE LOCAL BOARD, WITHOUT CHARGE, THE  
16 SPACE THAT IS NEEDED IN THE BUILDING FOR THE PROPER CONDUCT OF A VOTER  
17 REGISTRATION DRIVE.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
19 1, 2022.
