CHAPTER

1 AN ACT concerning

2 Maryland Medical Assistance Program – Community Violence Prevention 3 Services

- 4 FOR the purpose of requiring the Maryland Medical Assistance Program to provide 5 community violence prevention services; establishing requirements for prevention 6 professionals seeking certification as a certified violence prevention professional and 7 entities that employ or contract with certified violence prevention professionals; requiring the Maryland Department of Health to approve a training and certification 8 9 program for violence prevention professionals; requiring the Department to obtain a 10 waiver from the Centers for Medicare and Medicaid Services to provide community 11 violence prevention services under the Program; and generally relating to the 12 Maryland Medical Assistance Program and community violence prevention services.

- 32 "CERTIFIED VIOLENCE PREVENTION PROFESSIONAL" MEANS A **(2)** PREVENTION PROFESSIONAL WHO MEETS THE REQUIREMENTS OF SUBSECTION (C) 33 34 OF THIS SECTION.

- 1 (3) "COMMUNITY VIOLENCE" MEANS INTENTIONAL ACTS OF 2 INTERPERSONAL VIOLENCE COMMITTED IN PUBLIC AREAS BY INDIVIDUALS WHO 3 ARE NOT FAMILY MEMBERS OR INTIMATE PARTNERS OF THE VICTIM.
- 4 "COMMUNITY VIOLENCE PREVENTION SERVICES" MEANS **(4)** (I)EVIDENCE-BASED, TRAUMA-INFORMED, SUPPORTIVE, 5 AND NONPSYCHOTHERAPEUTIC SERVICES PROVIDED BY A CERTIFIED VIOLENCE 6 PREVENTION PROFESSIONAL, WITHIN OR OUTSIDE A CLINICAL SETTING, FOR THE 8 PURPOSE OF PROMOTING IMPROVED HEALTH OUTCOMES AND POSITIVE 9 BEHAVIORAL CHANGE, PREVENTING INJURY RECIDIVISM, AND REDUCING THE LIKELIHOOD THAT AN INDIVIDUAL WHO IS THE VICTIM OF COMMUNITY VIOLENCE 10 11 WILL COMMIT OR PROMOTE VIOLENCE.
- 12 (II) "COMMUNITY VIOLENCE PREVENTION SERVICES"
 13 INCLUDES PEER SUPPORT AND COUNSELING, MENTORSHIP, CONFLICT MEDIATION,
 14 CRISIS INTERVENTION, TARGETED CASE MANAGEMENT REFERRALS TO CERTIFIED
 15 OR LICENSED HEALTH CARE PROFESSIONALS OR SOCIAL SERVICES PROVIDERS,
 16 PATIENT EDUCATION, AND SCREENING SERVICES TO VICTIMS OF VIOLENCE.
- 17 (5) "INTERPERSONAL VIOLENCE" MEANS THE INTENTIONAL USE OF 18 PHYSICAL FORCE OR POWER AGAINST ANOTHER INDIVIDUAL BY AN INDIVIDUAL OR 19 A SMALL GROUP OF INDIVIDUALS.
- 20 (6) "PREVENTION PROFESSIONAL" HAS THE MEANING PROVIDED BY 21 THE NATIONAL UNIFORM CLAIM COMMITTEE, OR ITS SUCCESSOR, UNDER CODE 22 NUMBER 405300000X.
- 23 (B) THE PROGRAM SHALL PROVIDE COMMUNITY VIOLENCE PREVENTION 24 SERVICES TO PROGRAM RECIPIENTS WHO HAVE:
- 25 (1) (I) BEEN EXPOSED TO COMMUNITY VIOLENCE; OR
- 26 (II) A PERSONAL HISTORY OF INJURY SUSTAINED AS A RESULT OF AN ACT OF COMMUNITY VIOLENCE; AND
- 28 (2) BEEN REFERRED BY A CERTIFIED OR LICENSED HEALTH CARE
 29 PROVIDER OR SOCIAL SERVICES PROVIDER TO A CERTIFIED VIOLENCE PREVENTION
 30 PROFESSIONAL TO RECEIVE COMMUNITY VIOLENCE PREVENTION SERVICES AFTER
 31 THE PROVIDER MAKES A DETERMINATION THAT THE PROGRAM RECIPIENT IS AT AN

- 3 (1) COMPLETE AN ACCREDITED TRAINING AND CERTIFICATION
- 4 PROGRAM FOR CERTIFIED VIOLENCE PREVENTION PROFESSIONALS, APPROVED IN
- 5 ACCORDANCE WITH SUBSECTION (D) OF THIS SECTION; AND
- 6 (2) MAINTAIN THE CERTIFICATION COMPLETED UNDER ITEM (1) OF 7 THIS SUBSECTION.
- 8 (D) ON OR BEFORE JANUARY 1, 2023, THE DEPARTMENT SHALL APPROVE
- 9 AT LEAST ONE ACCREDITED TRAINING AND CERTIFICATION PROGRAM FOR
- 10 CERTIFIED VIOLENCE PREVENTION PROFESSIONALS, WHICH SHALL INCLUDE:
- 11 (1) AT LEAST 35 HOURS OF INITIAL TRAINING, ADDRESSING THE
- 12 **FOLLOWING:**
- 13 (I) THE PROFOUND EFFECTS OF TRAUMA AND VIOLENCE AND
- 14 THE BASICS OF TRAUMA-INFORMED CARE;
- 15 (II) COMMUNITY VIOLENCE PREVENTION STRATEGIES,
- 16 INCLUDING CONFLICT MEDIATION AND RETALIATION PREVENTION RELATED TO
- 17 COMMUNITY VIOLENCE;
- 18 (III) CASE MANAGEMENT AND ADVOCACY PRACTICES; AND
- 19 (IV) PATIENT PRIVACY AND THE FEDERAL HEALTH INSURANCE
- 20 PORTABILITY AND ACCOUNTABILITY ACT OF 1996; AND
- 21 (2) AT LEAST 6 HOURS OF CONTINUING EDUCATION EVERY 2 YEARS.
- 22 (E) AN ENTITY THAT EMPLOYS OR CONTRACTS WITH A CERTIFIED
- 23 VIOLENCE PREVENTION PROFESSIONAL TO PROVIDE COMMUNITY VIOLENCE
- 24 PREVENTION SERVICES SHALL:
- 25 (1) MAINTAIN DOCUMENTATION THAT THE CERTIFIED VIOLENCE
- 26 PREVENTION PROFESSIONAL HAS MET THE REQUIREMENTS OF SUBSECTION (C) OF
- 27 THIS SECTION; AND
- 28 (2) Ensure that the certified violence prevention
- 29 PROFESSIONAL IS PROVIDING COMMUNITY VIOLENCE PREVENTION SERVICES IN
- 30 COMPLIANCE WITH ANY APPLICABLE STANDARD OF CARE, RULE, REGULATION, AND
- 31 STATE OR FEDERAL LAW.

1 2	(F) THIS SECTION MAY NOT BE CONSTRUED TO ALTER THE SCOPE OF PRACTICE FOR ANY HEALTH CARE PROFESSIONAL.
3 4 5 6	SECTION 2. AND BE IT FURTHER ENACTED, That on or before October 1, 2022, the Maryland Department of Health shall apply to the Centers for Medicare and Medicaid Services for a waiver to provide community violence program services under the Maryland Medical Assistance Program.
7 8 9 10 11 12	SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take effect on the date that the waiver applied for in accordance with Section 2 of this Act is approved. If the waiver is not approved, Section 1 of this Act shall be null and void without the necessity of further action by the General Assembly. The Maryland Department of Health, within 5 days after receiving approval or denial of the wavier, shall forward a copy of the notice to the Department of Legislative Services.
13 14	SECTION 4. AND BE IT FURTHER ENACTED, That, subject to Section 3 of this Act, this Act shall take effect July 1, 2022.
