## A BILL ENTITLED

1 AN ACT concerning

2 **Worcester County – Alcoholic Beverages – Class L License**

3 FOR the purpose of establishing a Class L beer, wine, and liquor license in Worcester  
4 County; authorizing the Board of License Commissioners for the county to issue the  
5 license to a holder of a manufacturer’s license; specifying that the license authorizes  
6 the license holder to sell or provide samples of certain beer, wine, and liquor for  
7 on–premises consumption under certain circumstances; providing for the hours of  
8 sale and an annual license fee; and generally relating to alcoholic beverages in  
9 Worcester County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages**

23 33–102.

24 This title applies only in Worcester County.

2 (A) **THERE IS A CLASS L BEER, WINE, AND LIQUOR LICENSE.**

3 (B) **THE BOARD MAY ISSUE THE LICENSE TO THE HOLDER OF A**  
4 **MANUFACTURER'S LICENSE.**

5 (C) **THE LICENSE AUTHORIZES THE LICENSE HOLDER, FOR ON-PREMISES**  
6 **CONSUMPTION, TO:**

7 (1) **SELL BEER, WINE, AND LIQUOR PRODUCED BY THE HOLDER OR**  
8 **ANOTHER HOLDER OF A MANUFACTURER'S LICENSE; AND**

9 (2) **PROVIDE A SAMPLE OF THE BEER, WINE, OR LIQUOR THAT IS**  
10 **AUTHORIZED UNDER ITEM (1) OF THIS SUBSECTION AT NO COST.**

11 (D) **THE HOURS OF SALE FOR A CLASS L BEER, WINE, AND LIQUOR LICENSE**  
12 **ARE THE SAME AS THOSE FOR THE UNDERLYING MANUFACTURER'S LICENSE.**

13 (E) **THE ANNUAL LICENSE FEE IS \$250.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
15 1, 2022.
