  County; authorizing the Board of License Commissioners for the county to issue the

  the license holder to sell or provide samples of certain beer, wine, and liquor for
  on-premises consumption under certain circumstances; providing for the hours of
  sale and an annual license fee; and generally relating to alcoholic beverages in
  Worcester County.
