42 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

43 That the Laws of Maryland read as follows:

Article – Education

6–121.

(a) A teacher preparation program shall:

(1) Include the following components of instruction:

(i) Basic research skills and methods and training on the routine evaluation and use of research and data to improve student performance;

(ii) Differentiation of instruction and demonstration of cultural competence for students of diverse racial, ethnic, linguistic, and economic backgrounds with different learning abilities;

(iii) Implementation of restorative approaches for student behaviors;

(iv) Identifying and assessing, in the context of the classroom, typical student learning deficits and techniques to remedy learning deficits;

(v) Recognizing and effectively using high quality instructional materials, including digital resources and computer technology;

(vi) Core academic subjects that teachers will be teaching;

(vii) Methods and techniques for identifying and addressing the social and emotional needs of students, including trauma–informed approaches to pedagogy; [and]

(viii) Skills and techniques for effective classroom management; **AND**

(IX) TRAINING IN THE SKILLS AND TECHNIQUES FOR TEACHING EFFECTIVELY IN A VIRTUAL LEARNING ENVIRONMENT;

(2) Require program participants to demonstrate competency in each of the components required under paragraph (1) of this subsection;

(3) Provide training in the knowledge and skills required to understand and teach the Maryland curriculum frameworks; and

(4) On or after July 1, 2025, require passing a nationally recognized, portfolio–based assessment of teaching ability as a requirement for graduation.

1 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A COUNTY BOARD MAY

23 LANGUAGE LEARNERS, HAVE THE NECESSARY DEVICES AT HOME FOR VIRTUAL
24 EDUCATION DAYS, INCLUDING ACCESS TO WI-FI; AND

25 (IV) SPECIFIC STRATEGIES FOR THE CONTINUED
26 IMPLEMENTATION OF INDIVIDUALIZED EDUCATION PROGRAMS DURING THE
27 VIRTUAL EDUCATION DAY, INCLUDING SPECIALLY DESIGNED INSTRUCTION,
28 RELATED SERVICES, SUPPLEMENTARY AIDS AND SERVICES, AND ACCOMMODATIONS.

29 (D) A COUNTY SUPERINTENDENT MAY DECIDE TO PROVIDE A DAY OF
30 VIRTUAL EDUCATION FOR PUBLIC SCHOOL STUDENTS IN THE COUNTY ONLY IF:

31 (1) THE LOCAL SCHOOL SYSTEM HAS USED ALL THE DAYS
32 INCORPORATED INTO ITS CALENDAR FOR SCHOOL CLOSURES FOR SEVERE WEATHER
33 CONDITIONS;

1 **(2) THE COUNTY BOARD HAS AUTHORIZED THE COUNTY**
2 **SUPERINTENDENT TO PROVIDE VIRTUAL EDUCATION DAYS TO STUDENTS IN**
3 **ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION; AND**

4 **(3) THE COUNTY SUPERINTENDENT DETERMINES THAT SEVERE**
5 **WEATHER CONDITIONS ARE LIKELY TO PREVENT NORMAL ATTENDANCE AT THE**
6 **PUBLIC SCHOOL.**

7 **(E) (1) IF A COUNTY SUPERINTENDENT DECIDES TO PROVIDE A VIRTUAL**
8 **EDUCATION DAY FOR PUBLIC SCHOOL STUDENTS IN THE COUNTY, THE COUNTY**
9 **SUPERINTENDENT SHALL NOTIFY THE SCHOOL PRINCIPALS AS SOON AS POSSIBLE**
10 **AFTER THE DECISION IS MADE.**

11 **(2) A SCHOOL PRINCIPAL WHO RECEIVES NOTICE OF A VIRTUAL**
12 **EDUCATION DAY IMMEDIATELY SHALL NOTIFY THE STUDENTS, PARENTS, AND**
13 **SCHOOL STAFF OF THE IMPLEMENTATION OF THE VIRTUAL EDUCATION DAY.**

14 **(F) (1) A VIRTUAL EDUCATION DAY SHALL CONSIST OF NOT LESS THAN 4**
15 **HOURS OF SYNCHRONOUS INSTRUCTION, AND ASYNCHRONOUS INSTRUCTION**
16 **DESIGNED TO MAXIMIZE THE ADVANTAGES OF ONLINE ACCESS.**

18 **VIRTUAL EDUCATION DAY MODEL BEFORE IMPLEMENTATION OF THE FIRST VIRTUAL**
19 **EDUCATION DAY.**

21 **(a) The Department shall, in consultation with experienced and highly effective**
22 **teachers, including teachers on the career ladder under Title 6, Subtitle 10 of this article,**
23 **develop curriculum standards and curriculum resources for each subject at each grade level,**
24 **that build on one another in logical sequence, in core subjects that may be used by local**
25 **school systems and public school teachers.**

26 **(b) (1) The purpose of the curriculum standards and curriculum resources**
27 **developed under this section is to provide county boards with technical assistance to inform**
28 **high-quality instruction that will ultimately result in students meeting the college and**
29 **career readiness standards in the manner described under § 7-205.1 of this subtitle.**

30 **(2) The curriculum resources developed under this section shall include, for**
31 **each core subject at each grade level:**

32 **(i) Course syllabi;**

33 **(ii) Sample lessons for teachers to use as models;**

1 (iii) Examples of student work that meet standards for proficiency;

2 (iv) Explanations of why student work examples meet proficiency
 3 standards so that teachers know what student knowledge is required; and

4 (v) Curriculum units aligned with the course syllabi.

5 (3) In developing the curriculum resources under this subsection, the
 6 Department:

7 (i) May use as a model a course or unit developed by a teacher in or
 8 out of the State; but

9 (ii) Shall review each model course and unit for quality, using
 10 accepted benchmarks such as approval by EdReports or Tier 1 and Tier 2 evidence-based
 11 standards established by the federal Every Student Succeeds Act.

12 (4) The Department shall compile curriculum units in such a manner that:

13 (i) Complete courses are formed; and

14 (ii) When taken by a student in sequence, the student can achieve the
 15 college and career readiness standard adopted under § 7–205.1 of this subtitle by the end of
 16 grade 10.

17 (c) The Department shall submit curriculum resources and curriculum standards
 18 developed under this section to the State Board for adoption.

19 (d) (1) (I) ON OR BEFORE SEPTEMBER 1, 2022, THE DEPARTMENT
 20 SHALL:

21 1. ESTABLISH A STATEWIDE UNIVERSAL LEARNING
 22 MANAGEMENT SYSTEM FOR EVENTUAL USE IN ALL PUBLIC SCHOOLS IN THE STATE;

15 **[(e)] (F) (1) Using the assessments established under subsection [(d)] (E) of**
16 **this section, the Department shall identify low-performing schools.**

17 **(2) An Expert Review Team established under § 5–411 of this article, under**
18 **the supervision of the Department, shall visit schools identified under paragraph (1) of this**
19 **subsection according to the criteria established under § 5–411 of this article.**

20 **(3) If the Department, based on a recommendation of an Expert Review**
21 **Team, determines that a school’s low performance on assessments is, largely, due to**
22 **curricular problems, the school shall adopt the curriculum resources developed under this**
23 **section.**

24 **(4) Except as provided in paragraph (3) of this subsection, this section does**
25 **not require a public school or county board to adopt the Department’s curriculum standards**
26 **and curriculum resources and may not be construed to restrict a county board’s authority to**
27 **adopt curricula under § 4–111 of this article.**

30 **(a) In this subtitle the following words have the meanings indicated.**

31 **(b) “Quality online education standards” means the National Standards for**
32 **Quality Online Programs: Second Edition (2019).**

33 **(c) “Sponsor” means [the Department or] a county [school] board, having a**
34 **fiduciary responsibility for the operation of the virtual school.**

1 (d) “Virtual school” means a public school [established]:

2 (1) ESTABLISHED by [the Department or by] a county board OR
 3 MULTIPLE COUNTY BOARDS UNDER A WRITTEN AGREEMENT under § 4-109 of this
 4 article [in which the school];

5 (2) THAT uses [technology] ONE OR MORE TECHNOLOGIES to deliver [a
 6 significant portion of] instruction to its students [via the Internet in a virtual or remote
 7 setting] ENTIRELY OR PRIMARILY ONLINE; AND

8 (3) IN WHICH THE STUDENTS AND INSTRUCTORS PARTICIPATE
 9 REMOTELY FROM SEPARATE LOCATIONS.

11 THIS SUBTITLE DOES NOT APPLY TO:

12 (1) A VIRTUAL LEARNING OPPORTUNITY OFFERED BY THE
 13 DEPARTMENT OR A COUNTY BOARD UNDER § 7-1002 OF THIS TITLE;

14 (2) AN UPPER-LEVEL HIGH SCHOOL PROGRAM THAT:

15 (I) HAS ONLINE COMPONENTS; AND

16 (II) DESIGNS A STUDENT’S ACADEMIC PROGRAM TO MAXIMIZE
 17 THE FLEXIBILITY OF THE STUDENT’S SCHEDULE TO ACCOMMODATE THE STUDENT’S
 18 WORK SCHEDULE; OR

19 (3) A PUBLIC SCHOOL OPERATING UNDER A VIRTUAL EDUCATION
 20 PLAN DURING A PROLONGED STATE OF EMERGENCY UNDER SUBTITLE 14A OF THIS
 21 TITLE.

23 (a) (1) [Subject] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS
 24 SUBSECTION AND SUBJECT to the approval of the Department, a county board may
 25 establish [a] ONE virtual school FOR THE ELEMENTARY, MIDDLE, AND HIGH SCHOOL
 26 GRADE BANDS.

27 (2) THE DEPARTMENT MAY PROVIDE PRELIMINARY AUTHORIZATION
 28 TO A COUNTY BOARD TO ESTABLISH ONE ADDITIONAL VIRTUAL SCHOOL ON A
 29 SHOWING OF JUST CAUSE, AS DETERMINED BY THE DEPARTMENT.

1 **(3) EACH VIRTUAL SCHOOL SHALL RECEIVE FINAL APPROVAL FROM**
2 **THE STATE BOARD.**

3 **(4) THE DEPARTMENT MAY REVOKE APPROVAL OF A VIRTUAL**
4 **SCHOOL, SUBJECT TO FINAL APPROVAL OF THE STATE BOARD, IF DURING THE**
5 **PREVIOUS SCHOOL YEAR THE VIRTUAL SCHOOL FAILS TO MEET THE STANDARDS**
6 **ESTABLISHED BY THE DEPARTMENT IN REGULATION.**

7 **(B) A VIRTUAL SCHOOL MAY NOT INCLUDE CLASSES FOR**
8 **PREKINDERGARTEN OR KINDERGARTEN STUDENTS.**

9 **[(b)] (C) A virtual school is subject to all applicable federal and State laws and**
10 **regulations governing the operation of a public school.**

11 **(D) EACH APPROVED VIRTUAL SCHOOL SHALL HAVE A SCHOOL**
12 **ACCOUNTABILITY CODE ASSIGNED BY THE DEPARTMENT.**

13 **(E) (1) A COUNTY BOARD MAY NOT CONTRACT WITH A FOR-PROFIT**
14 **ENTITY, BUT MAY CONTRACT WITH A NONPROFIT ENTITY, TO OPERATE OR**
15 **ADMINISTER A VIRTUAL SCHOOL FOR THE COUNTY BOARD.**

16 **(2) THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION MAY**
17 **NOT BE CONSTRUED TO PROHIBIT A COUNTY BOARD FROM CONTRACTING WITH A**

13 **(F) THE COUNTY BOARD SHALL DEVELOP AN OUTREACH CAMPAIGN TO**
14 **PROVIDE INFORMATION TO THE PUBLIC ON THE AVAILABILITY OF THE VIRTUAL**
15 **SCHOOL OPTION.**

17 **(a) A virtual school shall provide each enrolled student:**

18 **(1) Access to a sequential curriculum approved by the State Board that**
19 **meets or exceeds the standards adopted by the county board in the county of the virtual**
20 **school's principal place of business OR THE COUNTY DESIGNATED UNDER A WRITTEN**
21 **AGREEMENT BETWEEN MULTIPLE COUNTY BOARDS;**

22 **(2) The same length of time for learning opportunities per academic year**
23 **that is required for public school students, unless the virtual school can show that a student**
24 **has demonstrated mastery or completion of the subject area; [and]**

25 **(3) Regular assessment in the core areas of instruction as required by**
26 **regulations adopted by the State Board under [§ 7-1408] § 7-1409 of this subtitle; AND**

27 **(4) ACCESS TO THE FOLLOWING SERVICES:**

28 **(I) TO THE EXTENT PRACTICABLE, EXTRACURRICULAR**
29 **ACTIVITIES AT THE PUBLIC SCHOOL THE STUDENT WOULD OTHERWISE BE REQUIRED**
30 **TO ATTEND;**

31 **(II) NOTWITHSTANDING ANY OTHER LAW OR REGULATION AND**
32 **SUBJECT TO A PARTICIPATION AGREEMENT BETWEEN THE PUBLIC SCHOOL AND THE**
33 **PARENT OR GUARDIAN OF THE STUDENT, PARTICIPATION IN ORGANIZED ATHLETICS**

SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 31, 2022, the State Superintendent of Schools shall submit a report to the State Board of Education and, in accordance with § 2-1257 of the State Government Article, the General Assembly on findings and recommendations regarding the appropriate balance of the number of hours of synchronous learning and asynchronous learning for instructional effectiveness of students in virtual schools based on research that has systematically examined this issue and collaboration with local school systems.

SECTION 3. AND BE IT FURTHER ENACTED, That:

(a) (1) Subject to paragraph (2) of this subsection, a virtual school established and operated by a county board of education under § 4-109 of the Education Article and approved by the State Department of Education under § 7-1402 of the Education Article before the effective date of this Act, including a virtual education program established through the Eastern Shore of Maryland Educational Consortium for students enrolled in public schools in counties that are members of the Consortium, may continue to operate as a virtual school through the 2023-2024 school year.
