CHAPTER _____

1 AN ACT concerning

2 **Natural Resources – Wildlife Trafficking Prevention**

3 FOR the purpose of prohibiting a person from purchasing, selling, offering for sale, or
4 possessing with the intent to sell certain parts or products of certain animal species
5 under certain circumstances, subject to certain exceptions; authorizing a court to
6 order that a person who violates this Act pay certain restitution; requiring that fines
7 and restitution imposed under this Act be credited to the State Wildlife Management
8 and Protection Fund to be used for the preservation of threatened or endangered
9 species; and generally relating to the prevention of wildlife trafficking in the State.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Natural Resources

10–209.

(a) In this section, “Fund” means the State Wildlife Management and Protection Fund.

(b) There is a State Wildlife Management and Protection Fund in the Department.

(c) The purpose of the Fund is to finance the scientific investigation, protection, propagation, and management of wildlife.

(d) The Department shall administer the Fund.

(e) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of the State Finance and Procurement Article.

(2) The Treasurer shall hold the Fund separately and the Comptroller shall account for the Fund.

(f) The Fund consists of:

(1) Any money received for a license, stamp, application, or permit fee under this title, unless otherwise provided; [and]

(2) Any investment earnings of the Fund; AND

(3) FINES AND RESTITUTION PAID FOR VIOLATIONS RELATING TO WILDLIFE TRAFFICKING UNDER SUBTITLE 2B OF THIS TITLE.

(g) The Fund may be used only for:

(1) The scientific investigation, protection, propagation, and management of wildlife; and

(2) Administrative costs calculated in accordance with § 1–103(b)(2) of this article.

(h) (1) The Treasurer shall invest the money of the Fund in the same manner as other State money may be invested.

1 (2) Any investment earnings of the Fund may not be transferred or revert
2 to the General Fund of the State, but shall remain in the Fund.

3 (i) Expenditures from the Fund may be made only in accordance with the State
4 budget.

25 (3) FOR A SECOND OR SUBSEQUENT OFFENSE FOR WHICH THE VALUE

27 IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT
28 EXCEEDING THE GREATER OF \$10,000 OR 3 TIMES THE VALUE OF THE COVERED
29 ANIMAL SPECIES PART OR PRODUCT.

30 (B) IF A PERSON IS CONVICTED OF VIOLATING THIS SUBTITLE, IN ADDITION
31 TO ANY OTHER PENALTY PROVIDED IN THIS TITLE, THE COURT MAY ORDER THE
32 PERSON TO PAY RESTITUTION TO THE STATE IN AN AMOUNT NOT EXCEEDING 2

1 TIMES THE VALUE OF THE COVERED ANIMAL SPECIES PART OR PRODUCT IN
2 QUESTION.

3 (C) FINES AND RESTITUTION IMPOSED UNDER THIS SECTION SHALL BE
4 CREDITED TO THE DEPARTMENT FOR THE BENEFIT OF THE STATE WILDLIFE
5 MANAGEMENT AND PROTECTION FUND ESTABLISHED UNDER § 10-209 OF THIS
6 TITLE, TO BE USED ONLY FOR THE PRESERVATION OF THREATENED OR
7 ENDANGERED SPECIES.

19 THE DEPARTMENT MAY ADOPT REGULATIONS TO IMPLEMENT THIS SUBTITLE.
