A BILL ENTITLED

Task Force to Study the Laws of Intestacy in Maryland

FOR the purpose of establishing the Task Force to Study the Laws of Intestacy in Maryland; and generally relating to the Task Force to Study the Laws of Intestacy in Maryland.

SECTION 1 BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.

- 8 (a) There is a Task Force to Study the Laws of Intestacy in Maryland.
- 9 (b) The Task Force consists of the following members:

- 12 (2) one member of the House of Delegates, appointed by the Speaker of the 13 House; and
- 14 (3) the following members, appointed by the Governor:
- 15 (i) an orphans' court judge residing in a jurisdiction of more than
- 16 250,000 people;
- 17 (ii) an orphans' court judge residing in a jurisdiction of fewer than
- 18 250,000 people;

(d) 11 (e) A member of the Task Force: 12 may not receive compensation as a member of the Task Force; but (1) 13 (2)is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget. 14 (f) 15 The Task Force shall: 16 examine the laws of intestacy in Maryland; (1)17 (2)analyze and compare the laws and practices of other states relating to 18 the laws of intestacy; 19 (3)examine any other research, analysis, or guidance related to the laws 20 of intestacy that the Task Force determines to be relevant; and 21**(4)** make recommendations to revise the laws of intestacy in Maryland. 22(g) On or before January 1, 2023, the Task Force shall report its findings and recommendations to the Governor and, in accordance with § 2-1257 of the State 2324Government Article, the General Assembly. 25SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 26 1, 2022. It shall remain effective for a period of 1 year and, at the end of June 30, 2023, this 27 Act, with no further action required by the General Assembly, shall be abrogated and of no 28 further force and effect.
