5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 6 That the Laws of Maryland read as follows:

10 (1) ~~Five voting members;~~

11 (2) ~~Subject to subsection (f) of this section, one nonvoting student~~

13 (3) ~~The County Commissioners, who are nonvoting ex officio members.~~

14 (f) (1) ~~The student representative shall:~~

15 (i) ~~Be an eleventh or a twelfth grade student in the Carroll County~~
 16 ~~public school system elected by the high school students of the county in accordance with~~
 17 ~~procedures established by the school system;~~

18 (ii) ~~Be a student government association representative at the~~
 19 ~~student's high school;~~

20 (iii) ~~Serve for 1 year beginning on July 1 after the election of the~~

 27 ~~the county board, the student representative may not attend an executive session of the~~

1 (a) The president of the county board is entitled to receive ~~[\$9,000]~~ **\$13,000**
2 annually as compensation and the other voting members are entitled to receive ~~[\$8,000]~~
3 **\$12,000** each annually as compensation.

4 (b) The compensation of the president and the voting members described in
5 subsection (a) of this section shall be paid in four equal quarterly installments.

6 (c) (1) (i) A student representative who completes a full term on the county
7 board shall be entitled to a scholarship of \$3,500 to be applied to the student's higher
8 education costs.

9 (ii) The scholarship shall be paid directly to the educational
10 institution that the student attends.

11 (iii) ~~¶~~A student may receive not more than two scholarships of \$3,500
12 each regardless of the number of terms the student serves as the student representative of
13 the county board.

14 (iv)~~¶~~ The scholarship may not be considered compensation for the
15 purpose of calculating taxable income.

16 (2) On the submission of expense vouchers, the student representative is
17 entitled to reimbursement for travel and other expenses incurred in the performance of
18 official duties for the county board.

19 (3) The student representative is not entitled to any compensation or
20 payment other than that specified under paragraphs (1) and (2) of this subsection for work
21 as the student representative of the county board.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2022.
