CHAPTER _____

1 AN ACT concerning

2 **Prince George's County – School Board Districts – Redistricting Plan**

3 FOR the purpose of altering the boundaries of the school board districts for election of the
4 members of the Prince George's County Board of Education; and generally relating
5 to the school board districts for the Prince George's County Board of Education.

6 BY repealing and reenacting, with amendments,
7 Article – Education
8 Section 3–1001
9 Annotated Code of Maryland
10 (2018 Replacement Volume and 2021 Supplement)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Education**

16 geographical boundaries of the election districts and precincts:

17 (i) As reviewed and certified by the Prince George's County Board
18 of Elections or its designees before the precinct boundaries were reported to the U.S.
19 Bureau of the Census as part of the [2010] **2020** Census Redistricting Data Program; and

2 94–171 census block maps provided by the U.S. Bureau of the Census and as reviewed and
3 corrected by the Department of Planning.

4 (2) Where precincts are split between board of education districts, census
5 tract and block numbers, as indicated in the P.L. 94–171 data or shown on the P.L. 94–171
6 census block maps provided by the U.S. Bureau of the Census and referred to in this
7 subtitle, are used to define the boundaries of board of education districts.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
 14 measure, is necessary for the immediate preservation of the public health or safety, has
 15 been passed by a yea and nay vote supported by three-fifths of all the members elected to
 16 each of the two Houses of the General Assembly, and shall take effect from the date it is
 17 enacted.
