## A BILL ENTITLED

1 AN ACT concerning

2 **Small Claims – Examination in Aid of Enforcement – Prohibition on Arrest or**  
3 **Incarceration for Failure to Appear**

4 FOR the purpose of prohibiting an individual from being arrested or incarcerated for failure  
5 to respond to certain orders to appear in court relating to an examination in aid of  
6 enforcement of a money judgment entered in a small claim action in the District  
7 Court; and generally relating to enforcement of certain money judgments.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Courts and Judicial Proceedings**

16 **11-704.**

17 **AN INDIVIDUAL MAY NOT BE ARRESTED OR INCARCERATED FOR FAILURE TO**  
18 **RESPOND TO AN ORDER TO APPEAR IN COURT:**

19 **(1) FOR AN EXAMINATION IN AID OF ENFORCEMENT OF A MONEY**  
20 **JUDGMENT ENTERED IN A SMALL CLAIM ACTION IN THE DISTRICT COURT; OR**

21 **(2) TO SHOW CAUSE WHY THE INDIVIDUAL SHOULD NOT BE FOUND IN**  
22 **CONTEMPT FOR FAILURE TO APPEAR IN COURT FOR AN EXAMINATION IN AID OF**  
23 **ENFORCEMENT OF A MONEY JUDGMENT ENTERED IN A SMALL CLAIM ACTION IN THE**

1 **DISTRICT COURT.**

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to:

3 (1) any order to appear for an examination in aid of enforcement of a money  
4 judgment entered in a small claim action in the District Court on or after the effective date  
5 of this Act; and6 (2) any show cause order for contempt for failure to appear in court for an  
7 examination in aid of enforcement of a money judgment entered in a small claim action in  
8 the District Court on or after the effective date of this Act.9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
10 October 1, 2022.
