CHAPTER _____

1 AN ACT concerning

2 **State Finance and Procurement – Procedures and Pricing and Selection**
3 **Committee for Preferred Providers**

4 FOR the purpose of renaming the Pricing and Selection Committee for Blind Industries
5 and Services of Maryland and the Employment Works Program to be the Pricing and
6 Selection Committee for Preferred Providers; requiring that Maryland Correctional
7 Enterprises provide the proposed prevailing average market price of certain goods
8 and services that are available from Maryland Correctional Enterprises to the
9 Pricing and Selection Committee; requiring the Pricing and Selection Committee to
10 review and verify the prevailing average market prices of certain goods and services;
11 altering the duties of the Department of Information Technology relating to
12 procurement; renaming the Purchasing Bureau in the Department of General
13 Services to be the Office of State Procurement, led by the Chief Procurement Officer;
14 establishing certain duties and authority of the Chief Procurement Officer; altering
15 the list of units that are defined as “designated procurement units”; authorizing the
16 Chief Procurement Officer to establish certain fees under certain circumstances;
17 authorizing certain types of procurement to be conducted by electronic means;
18 renaming the Electronic Transaction Fund in the Department to be the Operations
19 Revenue Fund; altering the procedures used by certain units when procuring certain
20 goods and services; repealing a requirement that a procurement officer post the
21 amount of each bid at the time it is received; establishing that the Employment
22 Works Program and an Employment Works Program vendor are not subject to
23 certain cost savings requirements; altering the duties of the Pricing and Selection
24 Committee; providing that certain provisions relating to the use of eMaryland

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Correctional Services**

23 3–515.

24 (a) A unit of State government shall purchase from Maryland Correctional
25 Enterprises any goods or services that are available from Maryland Correctional
26 Enterprises and that Maryland Correctional Enterprises can provide at a price not
27 exceeding the prevailing average market price as determined by the [Department of
28 General Services] **PRICING AND SELECTION COMMITTEE FOR PREFERRED**
29 **PROVIDERS.**

30 (b) **THE PRICING AND SELECTION COMMITTEE FOR PREFERRED**
31 **PROVIDERS SHALL REVIEW AND VERIFY THE PREVAILING AVERAGE MARKET**
32 **PRICES, AS PROPOSED BY MARYLAND CORRECTIONAL ENTERPRISES:**

33 **(1) WHEN CHANGES ARE MADE TO THE PRICING OF EXISTING GOODS**
34 **AND SERVICES THAT ARE AVAILABLE FROM MARYLAND CORRECTIONAL**
35 **ENTERPRISES; AND**

36 **(2) FOR NEW GOODS OR SERVICES THAT MARYLAND CORRECTIONAL**

1 **ENTERPRISES INTENDS TO MAKE AVAILABLE.**

2 (C) (1) The contracting unit shall inform each unit of State government for
3 which it procures goods or services within 60 days after the award of a contract.

4 (2) Quarterly, each unit that requires goods or services for its operations
5 shall inform Maryland Correctional Enterprises of its anticipated orders during the next
6 3-month period.

7 (3) If Maryland Correctional Enterprises is unable to provide any of the
8 goods or services under the contract, Maryland Correctional Enterprises shall notify the
9 contracting unit so that appropriate alternative action may be taken to meet the needs of
10 units of State government for which the contracting unit procures goods or services.

11 [(c)] (D) The Board of Public Works:

12 (1) shall suspend the application of subsection (a) of this section if the
13 Board of Public Works finds that the purposes of Division II of the State Finance and
14 Procurement Article are being unduly eroded due to the volume and scope of activities and
15 sales by Maryland Correctional Enterprises; and

16 (2) may suspend the application of subsection (a) of this section for data
17 entry services that involve information that is protected from disclosure under Title 4 of
18 the General Provisions Article.

19 **Article – State Finance and Procurement**

20 3A-301.

21 (a) In this subtitle the following words have the meanings indicated.

22 (d) (1) “Development” means all expenditures for a new information
23 technology system or an enhancement to an existing system including system:

24 (i) planning;

25 (ii) [procurement;

26 (iii)] creation;

27 [(iv)] (III) installation;

28 [(v)] (IV) testing; and

29 [(vi)] (V) initial training.

1 (2) "Development" does not include:

2 (i) ongoing operating costs, software or hardware maintenance,
3 routine upgrades, or modifications that merely allow for a continuation of the existing level
4 of functionality; or

5 (ii) expenditures made after a new or enhanced system has been
6 legally accepted by the user and is being used for the business process for which it was
7 intended.

8 (f) "Information technology" means all electronic information processing
9 [hardware and software], including:

10 (1) maintenance;

11 (2) telecommunications; [and]

12 **(3) HARDWARE;**

13 **(4) SOFTWARE; AND**

14 **[(3)] (5)** associated [consulting] services.

15 3A-401.

16 (a) The Department shall:

17 (1) coordinate the development, [procurement,] management, and
18 operation of telecommunication equipment, systems, and services by State government;

19 (2) acquire and manage common user telecommunication equipment,
20 systems, or services and charge units of State government for their proportionate share of
21 the costs of installations, maintenance, and operation of the common user
22 telecommunication equipment, systems, or services;

23 (3) promote compatibility of telecommunication systems by developing
24 policies, procedures, and standards for the acquisition and use of telecommunication
25 equipment, systems, and services by units of State government;

26 (4) coordinate State government telecommunication systems and services
27 by reviewing requests by units of State government for telecommunication equipment,
28 systems, or services;

29 (5) advise units of State government about planning, acquisition, and
30 operation of telecommunication equipment, systems, or services; and

1 (6) provide radio frequency coordination for State and local governments
2 in accordance with regulations of the Federal Communications Commission.

3 (b) The Department may make arrangement for a user other than a unit of State
4 government to have access to and use of State telecommunication equipment, systems, and
5 services and shall charge the user any appropriate amount to cover the cost of installation,
6 maintenance, and operation of the telecommunication equipment, system, or service
7 provided.

8 4-206.

9 (a) The following units are in the Department:

10 (1) the Board of Architectural Review;

11 (2) [the General Professional Services Selection Board;

12 (3) the Purchasing Bureau] **THE OFFICE OF STATE PROCUREMENT;**
13 and

14 [(4)] **(3)** any other unit that is in the Department under any other law.

15 4-301.

16 (a) In this subtitle the following words have the meanings indicated.

17 (b) "Bid" means a bid, proposal, or other response to a solicitation.

18 **(c) (1) "SERVICES" MEANS THE RENDERING OF TIME, EFFORT, OR WORK,**
19 **RATHER THAN THE FURNISHING OF A SPECIFIC PHYSICAL PRODUCT OTHER THAN**
20 **REPORTS INCIDENTAL TO THE REQUIRED PERFORMANCE.**

21 **(2) "SERVICES" INCLUDES MAINTENANCE,**
22 **CONSTRUCTION-RELATED SERVICES, ARCHITECTURAL SERVICES, ENGINEERING**
23 **SERVICES, AND THE PROFESSIONAL, PERSONAL, OR CONTRACTUAL SERVICES**
24 **PROVIDED BY ATTORNEYS, ACCOUNTANTS, PHYSICIANS, CONSULTANTS, AND OTHER**
25 **PROFESSIONALS WHO ARE INDEPENDENT CONTRACTORS.**

26 [(c)] **(D)** "Supplies" means tangible property, including equipment and
27 materials.

28 4-302.

29 There is [a Purchasing Bureau] **AN OFFICE OF STATE PROCUREMENT** in the
30 Department.

1 4-303.

2 The Secretary may delegate any power or duty set forth in Part I or Part II of this
3 subtitle to the Chief [of the Purchasing Bureau] **PROCUREMENT OFFICER OF THE**
4 **OFFICE OF STATE PROCUREMENT.**

5 4-307.

6 The Secretary **OR THE CHIEF PROCUREMENT OFFICER** shall provide a copy of
7 each award for supplies to the requisitioning unit.

8 4-310.

9 Except as otherwise specifically provided by law, each unit of the Executive Branch
10 of the State Government shall purchase all supplies **AND SERVICES** through or with the
11 approval of the Secretary **OR THE CHIEF PROCUREMENT OFFICER.**

12 4-311.

13 **[An] EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED BY LAW, AN** invoice for
14 supplies purchased by the Secretary, **BY THE CHIEF PROCUREMENT OFFICER,** or by any
15 unit that procures supplies under Division II of this article may not be paid until the invoice
16 has been approved by the Secretary, **THE CHIEF PROCUREMENT OFFICER,** or a designee
17 of the Secretary **OR THE CHIEF PROCUREMENT OFFICER.**

18 4-312.

19 **[Consistent] EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED BY LAW AND**
20 **CONSISTENT** with Division II of this article, the Secretary **OR CHIEF PROCUREMENT**
21 **OFFICER** shall set standards for supplies to be purchased by a unit, including standards
22 for electronic equipment used by State employees or the public for communications that are
23 consistent with the standards for nonvisual access information technology issued under §
24 3-410 of this article.

25 4-313.

26 Consistent with Division II of this article, the Secretary **OR THE CHIEF**
27 **PROCUREMENT OFFICER** shall contract for or purchase any supplies **OR SERVICES** for a
28 unit except:

29 **(1)** an item that the Secretary **OR CHIEF PROCUREMENT OFFICER:**

30 **[(1)] (I)** determines is strictly perishable;

31 **[(2)] (II)** determines is impracticable for the unit to purchase through or

1 with the approval of the Secretary **OR CHIEF PROCUREMENT OFFICER**; or

2 **[(3)] (III)** permits the unit to purchase with the approval of the Secretary
3 **OR CHIEF PROCUREMENT OFFICER; OR**

4 **(2) SUPPLIES OR SERVICES AUTHORIZED BY STATUTE TO BE**
5 **PROCURED BY ANOTHER PRIMARY PROCUREMENT UNIT OR DELEGATED TO**
6 **ANOTHER UNIT.**

7 4–315.

8 (a) An employee of a unit that procures supplies under Division II of this article
9 whose salary and expenses are paid from the fees of the employee's office may not pay any
10 contractor or seller for any article of any kind acquired for the unit unless the invoice
11 approved by the employee is also approved by the Secretary **OR CHIEF PROCUREMENT**
12 **OFFICER** or a designee of the Secretary **OR CHIEF PROCUREMENT OFFICER.**

13 (b) The Governor may remove an employee for any violation of the provisions of
14 this section.

15 4–316.

16 (a) Subject to the initial approval of the Secretary **OR CHIEF PROCUREMENT**
17 **OFFICER**, the appropriate purchasing unit for the following entities may use the services
18 of the Department to purchase **SERVICES**, materials, supplies, and equipment:

19 (1) a county;

20 (2) a municipality;

21 (3) a governmental unit in the State;

22 (4) a public or quasi–public agency that:

23 (i) receives State money; and

24 (ii) is exempt from taxation under § 501(c)(3) of the Internal Revenue
25 Code;

26 (5) a private elementary or secondary school that:

27 (i) either has been issued a certificate of approval from the State
28 Board of Education or is accredited by the Association of Independent Schools; and

29 (ii) is exempt from taxation under § 501(c)(3) of the Internal Revenue
30 Code; or

1 (6) a nonpublic institution of higher education as provided under § 17–106
2 of the Education Article.

3 (b) Notwithstanding subsection (a)(5) and (6) of this section, the Department may
4 not purchase religious materials on behalf of a private elementary or secondary school or a
5 nonpublic institution of higher education.

6 (c) The purchasing authority under this section is in addition to, and not a
7 substitution for, the purchasing power of an entity under another law.

8 13–101.

9 (a) In this subtitle the following words have the meanings indicated.

10 (b) “Designated procurement unit” means:

11 (1) [the Department of Budget and Management;

12 (2)] the Department of General Services;

13 [(3) the Department of Information Technology; or]

14 [(4)] (2) the Department of Transportation; OR

15 (3) **THE DEPARTMENT OF INFORMATION TECHNOLOGY, ONLY WITH**
16 **RESPECT TO AN INFORMATION TECHNOLOGY MASTER CONTRACT EXECUTED**
17 **BEFORE JULY 1, 2022, UNTIL THE EARLIER OF:**

18 (I) **THE EXPIRATION DATE OF ALL INFORMATION TECHNOLOGY**
19 **MASTER CONTRACTS; OR**

20 (II) **JUNE 30, 2027.**

21 (c) “eMaryland Marketplace” OR “**EMARYLAND MARKETPLACE ADVANTAGE**”
22 means the Internet–based procurement system managed by the Department of General
23 Services.

24 (d) “Evaluated bid price” means the price of a bid after adjustment in accordance
25 with objective measurable criteria.

26 (e) “Master contracting” means a streamlined procurement method that provides
27 for the qualification of bidders and offerors for the procurement of services, supplies, or
28 commodities.

29 (f) (1) “Objective measurable criteria” means standards that enable the State

1 to compare the economy, effectiveness, or value of the subject of the bids.

2 (2) "Objective measurable criteria" includes standards of reliability,
3 operational costs, maintainability, useful life, and residual value.

4 (g) "Person" includes, unless the context requires otherwise:

5 (1) the State;

6 (2) a county, a municipal corporation, or any other political subdivision;

7 (3) any unit of the State government or a political subdivision.

8 (h) "Task order" means a procurement process in which only those vendors with
9 master contracts may compete to provide the services, supplies, or commodities under the
10 procurement.

11 13-102.1.

12 (a) A unit may not charge a fee to access eMaryland Marketplace.

13 (b) (1) Subject to approval by the Board of Public Works, the Chief
14 Procurement Officer may establish fees for the use of eMaryland Marketplace by an entity
15 that publishes a notice of a procurement, conducts a procurement, or publishes a notice of
16 award.

17 (2) The Chief Procurement Officer may not charge a unit, as defined in §
18 11-101(y) of this article, a fee under this subsection.

19 **(C) SUBJECT TO APPROVAL BY THE BOARD OF PUBLIC WORKS, THE CHIEF**
20 **PROCUREMENT OFFICER, IN CONSULTATION WITH THE DEPARTMENT OF BUDGET**
21 **AND MANAGEMENT, MAY ESTABLISH FEES FOR:**

22 **(1) TRAINING;**

23 **(2) STRATEGIC SOURCING; AND**

24 **(3) ADMINISTRATIVE COSTS.**

25 **[(c)] (D) (1) There is an [Electronic Transaction] OPERATIONS REVENUE**
26 **Fund in the Department of General Services.**

27 (2) The Fund is a special, nonlapsing fund that is not subject to § 7-302 of
28 this article.

29 (3) The State Treasurer shall hold the Fund separately, and the

1 Comptroller shall account for the Fund.

2 (4) The Fund consists of any fees imposed and collected under [paragraph]
3 **SUBSECTION (b)(1) OR (C)** of this [subsection] **SECTION** and § 13–226(c) of this title.

4 (5) The Fund shall be used by the Department of General Services to cover
5 the actual documented direct and indirect [costs of administering contracts through the use
6 of electronic transactions] **OPERATING EXPENSES OF THE OFFICE OF STATE**
7 **PROCUREMENT**.

8 13–111.

9 (a) This section applies to the procurement of supplies[, with an estimated
10 contract value of \$1,000,000 or more,] **AND SERVICES** by a primary procurement unit.

11 (b) (1) Whenever the head of a primary procurement unit or designee
12 determines that it is in the best interest of the State for a procurement contract to be based
13 on auction bids, a procurement officer shall seek bids by issuing an invitation for auction
14 bids.

15 (2) Subject to subsection (c) of this section, an invitation for auction bids
16 shall include:

17 (i) the specifications of the procurement contract;

18 (ii) whether the procurement contract will be awarded based on the
19 lowest bid price or the lowest evaluated bid price;

20 (iii) if the procurement contract will be based on evaluated bid price,
21 the objective measurable criteria by which the lowest evaluated bid price will be
22 determined;

23 (iv) the small business preference, if designated under § 13–103 of
24 this subtitle; and

25 (v) the date and time when bidding will commence and the date and
26 time when bidding will end or the event upon which bidding will end.

27 (c) (1) In the discretion of the procurement officer, the invitation for auction
28 bids may:

29 (i) include a request for unpriced technical offers or samples;

30 (ii) direct bidders to submit price bids after the unit evaluates the
31 technical offers or samples and finds they are acceptable under the criteria set forth in the
32 invitation for auction bids; and

1 (iii) inform all bidders who submitted technical offers or samples of
2 the identity of each bidder who submitted an acceptable technical offer or sample.

3 (2) Price bids may not be received until after the unit has completed
4 evaluation of the technical offers or samples.

5 (3) A price bid may not be received at any time if the bid is submitted by a
6 bidder whose technical offer or sample has been evaluated as unacceptable to the unit.

7 (d) A unit shall give public notice of an invitation for auction bids in the same
8 manner as required for an invitation for bids.

9 (e) (1) (i) Multiple price bids are permitted in response to an invitation for
10 auction bids.

11 (ii) When a bidder submits multiple bids, each bid shall be judged
12 independently and shall not revoke previous bids of that bidder.

13 (2) A procurement officer shall:

14 (i) receive bids in public at the time and place designated in the
15 invitation for auction bids; and

16 (ii) record [and post] the amount of each bid at the time it is received.

17 (3) (i) The amount of a price bid shall be available for public inspection
18 from the time it is received.

19 (ii) The identity of the bidder submitting a price bid shall not be
20 available for public inspection until bidding has ended.

21 (4) Except as provided in paragraph (5) of this subsection, a bid is
22 irrevocable, after receipt, for the period specified in the invitation for auction bids.

23 (5) A procurement officer may allow a bidder to correct or withdraw a bid
24 if correction or withdrawal is:

25 (i) allowed under regulations adopted under this Division II
26 applicable to an invitation for bids; and

27 (ii) approved in writing by the Office of the Attorney General.

28 (f) (1) After obtaining any approval required by law, the procurement officer
29 shall award the procurement contract to the responsible bidder who submits the responsive
30 bid that:

1 (i) is the lowest bid price; or

2 (ii) if the invitation for auction bids so provides, is the lowest
3 evaluated bid price.

4 (2) If, after bids have been received, a procurement officer determines that
5 only one responsible bidder has submitted a responsive bid, the unit may negotiate the
6 procurement contract with that one bidder under the procedure for sole source
7 procurement.

8 (3) (i) After bids have been received, a procurement officer may award
9 a procurement contract on the basis of revised bids if:

10 1. all bids are rejected under § 13–206(b) of this title;

11 2. all bid prices exceed the funds available for the
12 procurement; or

13 3. with the approval of the head of a primary procurement
14 unit or a designee, the procurement officer determines that all bids are unreasonable as to
15 at least one requirement and delay that would result from issuing a new invitation for
16 auction bids with revised specifications or quantities would be fiscally disadvantageous or
17 otherwise not in the best interests of the State.

18 (ii) If there is more than one bidder, discussion about revised
19 specifications or quantities shall be conducted with all responsible bidders who submitted
20 responsive bids. The bidders shall be treated fairly and equally with respect to any
21 discussions.

22 (iii) If one of the conditions set forth under subparagraph (i) of this
23 paragraph exists, as promptly as possible, the procurement officer shall:

24 1. issue an invitation for revised auction bids, which shall
25 state whether the award will be made without competitive negotiations; and

26 2. requires a prompt response to that invitation.

27 (iv) An invitation for revised auction bids is not subject to the notice
28 requirements in subsection (d) of this section.

29 (v) After revised bids have been submitted, negotiations with
30 bidders may not be conducted unless the procurement officer determines that there is a
31 compelling reason to negotiate.

32 (vi) After revised bids have been received and any approval required
33 by law has been obtained, the procurement officer shall award the procurement contract to
34 the responsible bidder who submits a responsive bid that:

- 1 1. is the lowest bid price; or
- 2 2. if the invitation for revised bids so provides, is the lowest
- 3 evaluated bid price.

4 (g) Not more than 30 days after the execution and approval of a procurement

5 contract awarded under this section, a unit shall publish notice of the award in eMaryland

6 Marketplace.

7 13–226.

8 (a) Unless otherwise prohibited by law, a primary procurement unit may conduct

9 procurement, including the solicitation[, bidding] **OF BIDS OR PROPOSALS,**

10 **EVALUATION,** award, execution, and administration of a contract, by electronic means as

11 provided in the Uniform Electronic Transactions Act in Title 21 of the Commercial Law

12 Article.

13 (b) Bidding **OR SUBMITTING A PROPOSAL** on a procurement contract by

14 electronic means shall constitute consent by the bidder **OR PROPOSER** to conduct by

15 electronic means all elements of the procurement of that contract which the unit agrees to

16 conduct by electronic means.

17 (c) (1) (i) Except as provided in paragraph (2) of the subsection, a unit

18 utilizing electronic means to conduct procurement or a private contractor furnishing to the

19 State electronic means for conducting procurement may charge a reasonable fee, [as

20 determined in consultation with] **ON APPROVAL BY** the Chief Procurement Officer, to the

21 bidder, **PROPOSER, OR EACH CONTRACT AWARDEE** for the use of the electronic means.

22 (ii) Any fees collected under subparagraph (i) of this paragraph shall

23 be deposited in the [Electronic Transaction] **OPERATIONS REVENUE** Fund established

24 under § 13–102.1(c) of this subtitle.

25 (2) Unless approved by the Board of Public Works, a fee may not be charged

26 under this subsection.

27 (d) The terms and conditions of a procurement conducted under this section shall

28 comply with the Uniform Electronic Transactions Act in Title 21 of the Commercial Law

29 Article.

30 14–102.

31 (a) Notwithstanding any other provision of this Division II, a State or State aided

32 or controlled entity shall buy supplies and services in accordance with § 14–103 of this

33 subtitle.

1 (b) The procurement of services from [a sheltered workshop] **THE EMPLOYMENT**
2 **WORKS PROGRAM OR AN EMPLOYMENT WORKS PROGRAM VENDOR** is not subject to
3 the cost savings requirements of § 13–405 of the State Personnel and Pensions Article.

4 14–106.

5 (a) In this section, “Committee” means the Pricing and Selection Committee for
6 [Blind Industries and Services of Maryland and the Employment Works Program]
7 **PREFERRED PROVIDERS.**

8 (b) There is a Pricing and Selection Committee for [Blind Industries and Services
9 of Maryland and the Employment Works Program] **PREFERRED PROVIDERS.**

10 (c) The Committee consists of the following 5 members:

11 (1) the Secretary of Transportation or a designee;

12 (2) the Secretary of General Services or a designee;

13 (3) the Secretary of Public Safety and Correctional Services or a designee;

14 (4) the Assistant Secretary for Vocational Rehabilitation within the State
15 Department of Education or a designee; and

16 (5) the Secretary of Labor or a designee.

17 (d) A member of the Committee:

18 (1) may not receive compensation; but

19 (2) is entitled to reimbursement for expenses under the Standard State
20 Travel Regulations as provided in the State budget.

21 (e) (1) Blind Industries and Services of Maryland shall provide staff for the
22 Committee.

23 (2) The staff provided in accordance with paragraph (1) of this subsection
24 shall:

25 (i) be a blind or a visually impaired associate of Blind Industries

3 (2) “Environmentally preferable product or service” means a product or
4 service that throughout the full life cycle of the product or service:

5 (i) is energy efficient, water efficient, biobased, nonozone depleting,

7 (ii) has other attributes recognized as environmentally preferable by
8 the Maryland Green Purchasing Committee.
