A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Resort Complex License**

3 FOR the purpose of establishing in Harford County a resort complex license that authorizes
4 the holder to sell beer, wine, and liquor at certain outlets in the resort complex; and
5 generally relating to alcoholic beverages licenses in Harford County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 22–102.

20 This title applies only in Harford County.

21 **22–1005.2.**

22 **(A) IN THIS SECTION, “RESORT COMPLEX” MEANS A PARCEL OR**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 **CONTIGUOUS PARCELS OF LAND:**

2 **(1) OF AT LEAST 10 ACRES;**

3 **(2) UNDER COMMON OWNERSHIP; AND**

4 **(3) WITH FACILITIES THAT:**

5 **(I) INCLUDE LODGING, CONFERENCE SPACES, MEETING**
6 **SPACES, ACTIVE OUTDOOR OPEN SPACES, WATERFRONT BEACH ACTIVITIES, OR A**
7 **MARINA;**

8 **(II) SERVE THE PUBLIC; AND**

9 **(III) RESULTED IN A CAPITAL INVESTMENT OF AT LEAST**
10 **\$500,000 EXCLUSIVE OF THE COST OF THE LAND.**

11 **(B) THERE IS A RESORT COMPLEX LICENSE.**

12 **(C) THE BOARD MAY ISSUE ONE RESORT COMPLEX LICENSE TO THE**
13 **PERSON OWNING, LEASING, OR OPERATING A RESORT COMPLEX.**

14 **(D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**
15 **AND LIQUOR FROM:**

16 **(1) ONE OR MORE OUTLETS IN THE RESORT COMPLEX WHERE THE**
17 **BEER, WINE, AND LIQUOR MAY BE CONSUMED IN CONJUNCTION WITH RECREATION**
18 **OR THE PLAYING OF MUSIC AND DANCING AT DESIGNATED LOCATIONS IN THE**
19 **RESORT COMPLEX;**

20 **(2) ONE OR MORE OUTLETS IN THE RESORT COMPLEX THAT OPERATE**
21 **AS A RESTAURANT;**

22 **(3) BARS OR COUNTERS AT ONE OR MORE LOCATIONS IN THE RESORT**
23 **COMPLEX DAILY FOR ON-PREMISES CONSUMPTION;**

24 **(4) ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR**
25 **CULINARY EDUCATION AND ENTERTAINMENT WHICH MAY INCLUDE OFF-PREMISES**
26 **CONSUMPTION; AND**

27 **(5) ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR**
28 **OFF-PREMISES CONSUMPTION.**

29 **(E) A LICENSE HOLDER MAY SERVE ALCOHOLIC BEVERAGES:**

1 **(1) AT ONE OR MORE OUTSIDE OUTLETS IN THE RESORT COMPLEX ON**
2 **MONDAY THROUGH SUNDAY, FROM 6 A.M. TO MIDNIGHT;**

3 **(2) AT ONE OR MORE INSIDE OUTLETS IN THE RESORT COMPLEX:**

4 **(I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.**
5 **THE FOLLOWING DAY; AND**

6 **(II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT; AND**

7 **(3) AT ONE DESIGNATED OUTLET FOR OFF-PREMISES CONSUMPTION:**

8 **(I) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M.**
9 **THE FOLLOWING DAY; AND**

10 **(II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT.**

11 **(F) A RESORT COMPLEX LICENSE IS EXEMPT FROM ANY QUOTA OR**
12 **RESTRICTION ON OFF-SALE LICENSES ISSUED FOR THE ELECTION DISTRICT IN**
13 **WHICH THE RESORT COMPLEX IS LOCATED.**

14 **(G) (1) CERTAIN AREAS IN A RESORT COMPLEX MAY BE EXCLUDED FROM**
15 **THE PORTION OF THE PROPERTY THAT IS CONSIDERED TO BE THE LICENSED**
16 **PREMISES.**

17 **(2) A PERSON OTHER THAN THE RESORT COMPLEX LICENSE HOLDER**
18 **MAY OBTAIN A DIFFERENT CLASS OF LICENSE FOR AN AREA EXCLUDED UNDER**
19 **PARAGRAPH (1) OF THIS SUBSECTION.**

20 **(H) A RESORT COMPLEX FOR WHICH THE LICENSE IS ISSUED IS SUBJECT TO**
21 **THE ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4-505 OF THIS**
22 **ARTICLE.**

23 **(I) (1) THE INITIAL LICENSE FEE IS \$3,500.**

24 **(2) BEGINNING MAY 1, 2023, THE ANNUAL LICENSE FEE IS \$6,000.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
26 1, 2022.
