A BILL ENTITLED

1 AN ACT concerning

2 **Public Utilities – Energy Efficiency and Conservation Programs – Energy**
3 **Performance Targets and Low–Income Housing**

4 FOR the purpose of requiring the Public Service Commission to include certain information
5 on the low–income EmPOWER programs in a certain annual report to the General
6 Assembly; requiring the Department of Housing and Community Development to
7 procure or provide for electricity customers energy efficiency and conservation
8 programs and services designed to achieve a certain target annual incremental gross
9 energy savings starting in a certain year; requiring certain contractors used for the
10 programs under this Act to meet certain job requirements; requiring the Commission
11 to update the weather–normalized gross retail sales against which savings are
12 measured for certain plans; requiring the target annual incremental gross energy
13 savings to be achieved based on an average of certain Department plans; requiring
14 the Department, on or before a certain date, to submit a plan to the Commission for
15 achieving the electricity savings and demand reduction target; requiring the
16 Department to develop a plan to coordinate and leverage funding sources to support
17 certain energy efficiency and other home upgrades and a plan to provide energy
18 efficiency retrofits to all low–income households by a certain date; establishing the
19 Green and Healthy Task Force to analyze and advance the coordination of resources
20 to address the housing needs of low–income communities; and generally relating to
21 energy performance targets and low–income housing.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Public Utilities**

6 7–211.

7 (k) On or before May 1 of each year, the Commission, in consultation with the
8 Maryland Energy Administration, shall report, subject to § 2–1257 of the State Government
9 Article, to the General Assembly on:

10 (1) the status of programs and services to encourage and promote the
11 efficient use and conservation of energy, including an evaluation of the impact of the
12 programs and services that are directed to low–income communities, low–
13 moderate–income communities to the extent possible, and other particular classes of
14 ratepayers;

15 (2) a recommendation for the appropriate funding level to adequately fund
16 these programs and services; [and]

17 **(3) FOR THE LOW–INCOME PROGRAMS UNDER § 7–211.1 OF THIS**
18 **SUBTITLE, INFORMATION THE DEPARTMENT OF HOUSING AND COMMUNITY**

20 **7–211.1(H) OF THIS SUBTITLE; AND**

24 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
25 INDICATED.

26 (2) “DEPARTMENT” MEANS THE DEPARTMENT OF HOUSING AND
27 COMMUNITY DEVELOPMENT.

28 (3) “LOW–INCOME PROGRAM” MEANS A PROGRAM THAT DELIVERS
29 ENERGY EFFICIENCY AND CONSERVATION MEASURES TO REDUCE UTILITY
30 EXPENSES FOR BUILDING OWNERS, MANAGERS, AND TENANTS IN HOUSING WITH
31 RESIDENTS WHO QUALIFY FOR THE DEPARTMENT’S LOW–INCOME ASSISTANCE
32 PROGRAMS, INCLUDING:

1 **(I) THE EMPOWER MARYLAND PROGRAM;**

2 **(II) THE MULTIFAMILY ENERGY EFFICIENCY AND HOUSING**
3 **AFFORDABILITY PROGRAM; AND**

4 **(III) THE WEATHERIZATION ASSISTANCE PROGRAM.**

5 **(4) “LOW-INCOME RESIDENTIAL” MEANS A COMMUNITY, BUILDING,**
6 **OR HOUSEHOLD WITH RESIDENTS WHO QUALIFY FOR THE DEPARTMENT’S**
7 **LOW-INCOME PROGRAMS.**

8 **(5) “TASK FORCE” MEANS THE GREEN AND HEALTHY TASK FORCE**
9 **ESTABLISHED UNDER § 7-211.2 OF THIS SUBTITLE.**

10 **(B) (1) FOR THE 2022-2024 PROGRAM CYCLE, THE DEPARTMENT SHALL**
11 **PROCURE OR PROVIDE FOR ELECTRICITY CUSTOMERS ENERGY EFFICIENCY AND**
12 **CONSERVATION PROGRAMS AND SERVICES.**

13 **(2) (I) THE PROGRAMS AND SERVICES REQUIRED UNDER**
14 **PARAGRAPH (1) OF THIS SUBSECTION SHALL BE DESIGNED TO ACHIEVE TARGET**
15 **ANNUAL INCREMENTAL GROSS ENERGY SAVINGS OF AT LEAST 0.4% PER YEAR**
16 **STARTING IN 2023.**

17 **(II) THE DEPARTMENT MAY USE THE SAVINGS ACHIEVED**
18 **THROUGH ALL FUNDING SOURCES TOWARD CALCULATING THE TARGET ANNUAL**
19 **INCREMENTAL GROSS ENERGY SAVINGS, IF THE FUNDING SOURCES MEET THE**
20 **STANDARDS OF PROGRAMS FUNDED THROUGH:**

21 **1. THE EMPOWER SURCHARGE; OR**

22 **2. THE U.S. DEPARTMENT OF ENERGY.**

23 **(3) (I) THE ENERGY SAVINGS DESCRIBED IN PARAGRAPH (2) OF**
24 **THIS SUBSECTION SHALL BE CALCULATED AS A PERCENTAGE OF THE 2019**
25 **WEATHER-NORMALIZED GROSS LOW-INCOME RESIDENTIAL RETAIL SALES FOR ALL**
26 **ELECTRIC COMPANIES.**

27 **(II) THE 2019 WEATHER-NORMALIZED GROSS LOW-INCOME**
28 **RESIDENTIAL RETAIL SALES FOR ALL ELECTRIC COMPANIES SHALL BE**
29 **DETERMINED BY MULTIPLYING THE AVERAGE 2019 RESIDENTIAL HOUSEHOLD**
30 **ELECTRICITY USAGE FOR ALL ELECTRIC COMPANIES BY THE NUMBER OF**
31 **HOUSEHOLDS:**

1 1. WITH INCOMES BELOW 250% OF THE FEDERAL
2 POVERTY LEVEL AS DETERMINED BY THE FEDERAL CENSUS; OR

3 2. THAT MEET THE ELIGIBILITY CRITERIA APPROVED BY
4 THE COMMISSION FOR LOW-INCOME PROGRAMS.

5 (4) FOR WEATHERIZATION OF LEASED OR RENTED RESIDENCES, THE
6 DEPARTMENT SHALL ADOPT REGULATIONS TO ENSURE THAT:

7 (I) THE BENEFITS OF WEATHERIZATION ASSISTANCE,
8 INCLUDING UTILITY BILL REDUCTION AND PRESERVATION OF AFFORDABLE
9 HOUSING STOCK, ACCRUE PRIMARILY TO LOW-INCOME TENANTS OCCUPYING A
10 LEASED OR RENTED RESIDENCE; AND

11 (II) THE RENT ON THE RESIDENCE IS NOT INCREASED AND THE
12 TENANT IS NOT EVICTED AS A RESULT OF WEATHERIZATION PROVIDED UNDER THIS
13 SECTION.

14 (5) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE
15 PROGRAMS AND SERVICES PROVIDED UNDER PARAGRAPH (1) OF THIS SUBSECTION
16 MAY NOT USE THERMAL INSULATING MATERIALS FOR BUILDING ELEMENTS,
17 INCLUDING WALLS, FLOORS, CEILINGS, ATTICS, AND ROOF INSULATION, THAT
18 CONTAIN:

19 1. FORMALDEHYDE; OR

20 2. ANY SUBSTANCE THAT IS A CATEGORY 1
21 RESPIRATORY SENSITIZER AS DEFINED IN 29 C.F.R. PART 1910 (APPENDIX A).

22 (II) THERMAL INSULATING MATERIALS FOR BUILDING
23 ELEMENTS MAY NOT CONTAIN A SUBSTANCE UNDER SUBPARAGRAPH (I) OF THIS
24 PARAGRAPH IF THE SUBSTANCE:

25 1. WAS INTENTIONALLY ADDED; OR

26 2. IS PRESENT IN THE PRODUCT AT GREATER THAN 0.1%
27 BY WEIGHT.

28 (6) (I) THE DEPARTMENT SHALL GIVE PREFERENCE TO
29 CONTRACTORS THAT ARE MINORITY-OWNED, WOMEN-OWNED, OR
30 VETERAN-OWNED BUSINESSES IN THE STATE FOR PROCUREMENT PROCESSES
31 RELATED TO EMPOWER PROGRAMS.

1 **(II) THE DEPARTMENT’S APPROVED CONTRACTORS USED FOR**
2 **THE PROGRAMS UNDER THIS SECTION SHALL MEET THE FOLLOWING JOB**
3 **REQUIREMENTS:**

4 **1. PAY AT LEAST 150% OF THE STATE MINIMUM WAGE;**

5 **2. PROVIDE CAREER ADVANCEMENT TRAINING;**

6 **3. AFFORD EMPLOYEES THE RIGHT TO BARGAIN**
7 **COLLECTIVELY FOR WAGES AND BENEFITS;**

8 **4. PROVIDE PAID LEAVE;**

9 **5. BE CONSIDERED COVERED EMPLOYMENT FOR**
10 **PURPOSES OF UNEMPLOYMENT INSURANCE BENEFITS IN ACCORDANCE WITH TITLE**
11 **8 OF THE LABOR AND EMPLOYMENT ARTICLE;**

12 **6. ENTITLE THE EMPLOYEE TO WORKERS’**
13 **COMPENSATION BENEFITS IN ACCORDANCE WITH TITLE 9 OF THE LABOR AND**
14 **EMPLOYMENT ARTICLE;**

15 **7. BE COMPLIANT WITH FEDERAL AND STATE WAGE AND**
16 **HOUR LAWS FOR THE PREVIOUS 3 YEARS;**

17 **8. OFFER EMPLOYER–PROVIDED HEALTH INSURANCE**
18 **BENEFITS WITH MONTHLY PREMIUMS THAT DO NOT EXCEED 8.5% OF THE**
19 **EMPLOYEE’S NET MONTHLY EARNINGS; AND**

20 **9. OFFER RETIREMENT BENEFITS.**

21 **(C) THE WEATHER–NORMALIZED GROSS RETAIL SALES AGAINST WHICH**
22 **THE SAVINGS ARE MEASURED SHALL:**

23 **(1) REFLECT SALES ASSOCIATED WITH THE LOW–INCOME**
24 **RESIDENTIAL CUSTOMER CLASS SERVED BY PROGRAMS ADMINISTERED BY THE**
25 **DEPARTMENT; AND**

26 **(2) BE UPDATED BY THE COMMISSION FOR EACH PLAN SUBMITTED**
27 **UNDER SUBSECTION (E) OF THIS SECTION.**

28 **(D) THE TARGET ANNUAL INCREMENTAL GROSS ENERGY SAVINGS SHALL BE**
29 **ACHIEVED BASED ON THE 3–YEAR AVERAGE OF DEPARTMENT PLANS SUBMITTED IN**
30 **ACCORDANCE WITH SUBSECTION (E) OF THIS SECTION.**

1 **(E) (1) ON OR BEFORE SEPTEMBER 1, 2022, THE DEPARTMENT SHALL**
2 **SUBMIT A PLAN TO THE COMMISSION THAT DETAILS PROPOSALS FOR ACHIEVING**
3 **THE ELECTRICITY SAVINGS AND DEMAND REDUCTION TARGET UNDER SUBSECTION**
4 **(B) OF THIS SECTION FOR THE 2 SUBSEQUENT CALENDAR YEARS.**

5 **(2) THE PLAN SHALL INCLUDE:**

6 **(I) A DESCRIPTION OF THE PROPOSED ENERGY EFFICIENCY**
7 **AND CONSERVATION PROGRAMS AND SERVICES;**

8 **(II) A DESCRIPTION OF THE STEPS PROPOSED TO ENSURE**
9 **INSULATION MATERIALS MEET THE REQUIREMENTS UNDER SUBSECTION (B) OF**
10 **THIS SECTION;**

11 **(III) ANTICIPATED COSTS;**

12 **(IV) PROJECTED ELECTRICITY SAVINGS;**

13 **(V) A PROPOSED AVERAGE LIFETIME MEASURE THRESHOLD**
14 **THAT ENCOURAGES THE DELIVERY OF INSULATION AND WEATHERIZATION**
15 **MEASURES, DEVELOPED THROUGH A STAKEHOLDER ENGAGEMENT PROCESS; AND**

16 **(VI) ANY OTHER INFORMATION THAT THE COMMISSION**
17 **REQUESTS.**

18 **(3) THE DEPARTMENT SHALL PROVIDE THE COMMISSION WITH AN**
19 **UPDATE EVERY 6 MONTHS ON PLAN IMPLEMENTATION AND PROGRESS TOWARD**
20 **ACHIEVING THE ELECTRICITY SAVINGS AND DEMAND REDUCTION TARGET UNDER**
21 **SUBSECTION (B) OF THIS SECTION.**

22 **(4) THE COMMISSION SHALL REVIEW A PLAN TO DETERMINE**
23 **WHETHER THE PLAN IS ADEQUATE FOR ACHIEVING THE TARGET.**

24 **(F) THE COMMISSION SHALL WORK WITH THE DEPARTMENT TO ESTABLISH**
25 **ANY PROCEDURES NECESSARY TO DEVELOP AND IMPLEMENT A PLAN FOR**
26 **ACHIEVING THE ELECTRICITY SAVINGS AND DEMAND REDUCTION TARGET UNDER**
27 **SUBSECTION (B) OF THIS SECTION, INCLUDING SECURING COOPERATION FROM**
28 **ELECTRIC COMPANIES RELATED TO:**

29 **(1) FUNDING;**

30 **(2) COMMUNICATIONS;**

1 **(3) REFERRALS;**

2 **(4) DATA SHARING; AND**

3 **(5) ANY OTHER COOPERATION THAT THE COMMISSION DETERMINES**
4 **IS NECESSARY TO ACHIEVE THE ELECTRICITY SAVINGS UNDER SUBSECTION (B) OF**
5 **THIS SECTION.**

6 **(G) (1) THE DEPARTMENT SHALL DEVELOP A PLAN TO COORDINATE**
7 **FUNDING SOURCES AND LEVERAGE THE GREATEST FUNDING POSSIBLE TO**
8 **SUPPORT:**

9 **(I) HEALTH AND SAFETY UPGRADES;**

10 **(II) WEATHERIZATION;**

11 **(III) ENERGY EFFICIENCY; AND**

12 **(IV) OTHER GENERAL MAINTENANCE FOR LOW-INCOME**
13 **HOUSING.**

14 **(2) THE PLAN SHALL COORDINATE FUNDING AMONG:**

15 **(I) THE STRATEGIC ENERGY INVESTMENT FUND;**

16 **(II) FEDERAL WEATHERIZATION ASSISTANCE PROGRAMS;**

17 **(III) RATEPAYER CONTRIBUTIONS TO:**

18 **1. THE EMPOWER MARYLAND LIMITED INCOME**
19 **ENERGY EFFICIENCY PROGRAM; AND**

20 **2. THE MULTIFAMILY ENERGY EFFICIENCY AND**
21 **HOUSING AFFORDABILITY PROGRAM;**

22 **(IV) THE MARYLAND AFFORDABLE HOUSING TRUST FUND;**

23 **(V) U.S. DEPARTMENT OF HOUSING AND URBAN**
24 **DEVELOPMENT PROGRAMS, INCLUDING:**

25 **1. COMMUNITY DEVELOPMENT BLOCK GRANTS;**

1 **2. THE HOME INVESTMENT PARTNERSHIP GRANTS**
2 **PROGRAM; AND**

3 **3. LEAD HAZARD CONTROL AND HEALTHY HOMES**
4 **GRANTS;**

5 **(VI) U.S. DEPARTMENT OF AGRICULTURE PROGRAMS,**
6 **INCLUDING THE HOME REPAIR PROGRAM;**

7 **(VII) THE HEALTHY HOMES FOR HEALTHY KIDS PROGRAM;**

8 **(VIII) THE ENERGY EFFICIENCY AND CONSERVATION BLOCK**
9 **GRANT PROGRAM;**

10 **(IX) STATE APPROPRIATIONS; AND**

11 **(X) ANY OTHER SOURCE OF FUNDING THAT THE DEPARTMENT**
12 **OR THE TASK FORCE IDENTIFIES.**

13 **(3) THE DEPARTMENT SHALL COLLABORATE WITH THE MEMBERS OF**
14 **THE TASK FORCE AND IDENTIFY OTHER INTERESTED STAKEHOLDERS TO DEVELOP**
15 **THE PLAN.**

16 **(4) ON OR BEFORE DECEMBER 31, 2022, THE DEPARTMENT SHALL**
17 **SUBMIT THE PLAN TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF THE**
18 **STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY.**

19 **(H) (1) THE DEPARTMENT SHALL REPORT TO THE COMMISSION EACH**
20 **YEAR ON:**

21 **(I) FOR THE PROGRAMS THAT CONTRIBUTE TO ENERGY**
22 **EFFICIENCY AND WEATHERIZATION, DISAGGREGATED BY FUEL SOURCE AND**
23 **FUNDING SOURCE OR DEVELOPMENT FINANCE EFFORTS:**

24 **1. THE NUMBER OF PARTICIPANTS SERVED; AND**

25 **2. THE AMOUNT OF ENERGY SAVINGS; AND**

26 **(II) THE AMOUNT OF FUNDING THAT THE DEPARTMENT**
27 **RECEIVES, AND IS PROJECTED TO RECEIVE, FOR ENERGY EFFICIENCY AND**
28 **WEATHERIZATION FROM THE FUNDING SOURCES UNDER THIS SECTION.**

29 **(2) THE DEPARTMENT MAY SATISFY THE REPORTING REQUIREMENT**

1 UNDER THIS SUBSECTION BY INCLUDING THE REQUIRED INFORMATION IN THE
2 6-MONTH STATUS REPORTS TO THE COMMISSION.

3 (I) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT IF THE
4 EMPOWER MARYLAND PROGRAM IS EXTENDED BEYOND 2023, THE TARGET
5 ANNUAL INCREMENTAL GROSS ENERGY SAVINGS UNDER SUBSECTION (B) OF THIS
6 SECTION SHALL INCREASE TO:

7 (1) 0.53% IN 2024;

8 (2) 0.72% IN 2025; AND

9 (3) 1% IN 2026.

10 (J) THE DEPARTMENT, THE MARYLAND ENERGY ADMINISTRATION, AND
11 OTHER STATE AGENCIES SHALL APPLY FOR ALL FEDERAL FUNDING THAT MAY
12 BECOME AVAILABLE TO CARRY OUT THIS SECTION.

13 (K) (1) THE DEPARTMENT SHALL COLLABORATE WITH THE MEMBERS OF
14 THE TASK FORCE TO DEVELOP A PLAN, INCLUDING A BUDGET, A TIMELINE, AND
15 POTENTIAL FUNDING SOURCES, TO PROVIDE ENERGY EFFICIENCY RETROFITS TO

25 (2) TWO MEMBERS OF THE HOUSE OF DELEGATES, APPOINTED BY
26 THE SPEAKER OF THE HOUSE;

27 (3) THE SECRETARY OF HOUSING AND COMMUNITY DEVELOPMENT,
28 OR THE SECRETARY'S DESIGNEE;

29 (4) THE SECRETARY OF HUMAN SERVICES, OR THE SECRETARY'S

1 DESIGNEE;

2 (5) THE DIRECTOR OF THE MARYLAND ENERGY ADMINISTRATION,
3 OR THE DIRECTOR'S DESIGNEE;

4 (6) ONE REPRESENTATIVE OF THE OFFICE OF PEOPLE'S COUNSEL;
5 AND

6 (7) AS APPOINTED BY THE CHAIR OF THE TASK FORCE:

7 (I) ONE REPRESENTATIVE OF THE MARYLAND AFFORDABLE
8 HOUSING TRUST;

9 (II) ONE REPRESENTATIVE OF THE GREEN AND HEALTHY
10 HOMES INITIATIVE;

11 (III) ONE REPRESENTATIVE OF MARYLAND ENERGY
12 EFFICIENCY ADVOCATES;

13 (IV) ONE MEMBER WHO IS AN EXPERT IN PUBLIC HEALTH;

14 (V) ONE MEMBER FROM A COMMUNITY CONCERNED WITH
15 ENVIRONMENTAL JUSTICE;

16 (VI) ONE MEMBER WHO OWNS OR DEVELOPS AFFORDABLE
17 HOUSING;

18 (VII) ONE MEMBER WHO HAS RECEIVED ASSISTANCE FROM A
19 LOW-INCOME PROGRAM THAT DELIVERS ENERGY EFFICIENCY MEASURES; AND

20 (VIII) OTHER MEMBERS AS DETERMINED BY THE CHAIR OF THE
21 TASK FORCE.

22 (C) THE SECRETARY OF HOUSING AND COMMUNITY DEVELOPMENT, OR
23 THE SECRETARY'S DESIGNEE, SHALL SERVE AS CHAIR OF THE TASK FORCE.

24 (D) THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT
25 SHALL PROVIDE STAFF FOR THE TASK FORCE.

26 (E) A MEMBER OF THE TASK FORCE:

27 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE TASK
28 FORCE; BUT

1 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
2 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

3 **(F) THE TASK FORCE SHALL:**

4 **(1) BEGINNING JULY 1, 2022, MEET QUARTERLY FOR A PERIOD OF 3**
5 **YEARS;**

6 **(2) ADVANCE THE ALIGNMENT, BRANDING, AND COORDINATION OF**
7 **RESOURCES TO MORE EFFECTIVELY DELIVER GREEN AND HEALTHY HOUSING FOR**
8 **LOW-INCOME HOUSEHOLDS IN THE STATE;**

9 **(3) EXAMINE THE PUBLIC AND PRIVATE RESOURCES NEEDED TO**
10 **ADDRESS THE HOUSING NEEDS OF LOW-INCOME COMMUNITIES;**

11 **(4) DEVELOP POLICY AND STATUTORY RECOMMENDATIONS TO**
12 **ELIMINATE BARRIERS TO LOW-INCOME HOUSEHOLDS ACHIEVING HEALTHY,**
13 **ENERGY-EFFICIENT, AND AFFORDABLE HOUSING; AND**

14 **(5) ENGAGE WITH INTERESTED PARTIES AND COLLABORATE WITH**
15 **OTHER ENTITIES THAT CAN HELP ADVANCE THE GOALS OF THE TASK FORCE,**
16 **INCLUDING EXPERTS IN THE FIELD OF HEALTHY AND ENERGY-EFFICIENT HOUSING.**

17 **(G) ON OR BEFORE JULY 1, 2023, AND EACH JULY 1 THEREAFTER, THE**
18 **TASK FORCE SHALL REPORT ITS FINDINGS AND RECOMMENDATIONS TO THE**
19 **SECRETARY OF HEALTH, THE SECRETARY OF THE ENVIRONMENT, THE**
20 **COMMISSION, THE GOVERNOR, AND, IN ACCORDANCE WITH § 2-1257 OF THE STATE**
21 **GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2022.
