# Occupational Licensing Boards and Commission on Judicial Disabilities – Reporting Disciplinary Activities

4 FOR the purpose of requiring business occupation licensing boards to include on license,  $\mathbf{5}$ registration, and certification application and renewal forms an option for the 6 applicant to provide the applicant's gender, race, and ethnicity; requiring the 7 business occupation licensing boards to encourage applicants to provide gender, race, 8 and ethnicity information; requiring business and health occupation licensing boards 9 to include certain information related to disciplinary activities in the boards' annual reports; requiring the Commission on Judicial Disabilities to submit an annual 10 11 disciplinary activities report to the Governor and the General Assembly; and 12generally relating to reports of disciplinary activities by occupational licensing boards and the Commission on Judicial Disabilities. 13
