 - (2) On or before July 1, 2025, a law enforcement agency [of a county], other than a law enforcement agency described in paragraph (1) of this subsection, shall require the use of body—worn cameras, subject to the policy on the use of body—worn cameras developed by the law enforcement agency, by each law enforcement officer employed by the law enforcement agency who regularly interacts with members of the public as part of the law enforcement officer's official duties.

- 12 (d) (1) A law enforcement agency described in subsection (c) of this section 13 shall develop and maintain a written policy consistent with the policy published by the 14 Maryland Police Training and Standards Commission under subsection (b) of this section 15 for the use of body—worn cameras.
- 16 (2) A policy developed and maintained under paragraph (1) of this subsection shall specify which law enforcement officers employed by the law enforcement agency are required to use body—worn cameras.
- 19 (e) A body-worn camera that possesses the requisite technological capability 20 shall automatically record and save at least 60 seconds of video footage immediately prior 21 to the officer activating the record button on the device.
- 22 (f) A law enforcement agency may not negate or alter any of the requirements or policies established in accordance with this section through collective bargaining.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022, the effective date of Section 1 of Chapter 60 of the Acts of the General Assembly of 2021. If the effective date of Section 1 of Chapter 60 is amended, this Act shall take effect on the taking effect of Section 1 of Chapter 60.
