## A BILL ENTITLED

1 AN ACT concerning

2 **University of Maryland – Employees – Authorization to Fund–Raise**

3 FOR the purpose of authorizing an employee of the University of Maryland to solicit gifts  
4 or proposals for grants for the benefit of the University of Maryland Medical System  
5 Corporation in accordance with certain policies; and generally relating to University  
6 of Maryland employees and fund–raising.

7 BY repealing and reenacting, with amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – Education**

20 13–303.

21 (j) **(1)** The Board of Directors will coordinate with University fund–raising  
22 efforts all Medical System Corporation campaigns and solicitations for private gifts and  
23 proposals for private or federal grants.
