A BILL ENTITLED

1 AN ACT concerning

2 **Income Tax – Film Production Activity Tax Credit – Filming Locations**

3 FOR the purpose of requiring the Secretary of Commerce to make available, for film
4 production activities in certain counties, a certain percentage of the total amount of
5 tax credits that the Secretary may approve in a fiscal year; and generally relating to
6 the film production activity tax credit.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Tax – General**

15 10–730.

16 (f) (1) Except as provided in paragraph (2) of this subsection, the Secretary
17 may not issue tax credit certificates for credit amounts in the aggregate totaling more than:

18 (i) for fiscal year 2014, \$25,000,000;

19 (ii) for fiscal year 2015, \$7,500,000;

20 (iii) for fiscal year 2016, \$7,500,000;

21 (iv) for fiscal year 2019, \$8,000,000;

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (v) for fiscal year 2020, \$11,000,000; and

2 (vi) for fiscal year 2021 and each fiscal year thereafter, \$12,000,000.

3 (2) If the aggregate credit amounts under the tax credit certificates issued
4 by the Secretary total less than the maximum provided under paragraph (1) of this
5 subsection in any fiscal year, any excess amount may be carried forward and issued under
6 tax credit certificates in a subsequent fiscal year.

7 (3) The Secretary may not issue tax credit certificates for credit amounts
8 totaling more than \$10,000,000 in the aggregate for a single film production activity.

9 (4) (i) For fiscal year 2019 and each fiscal year thereafter, the Secretary
10 shall make 10% of the credit amount authorized under paragraph (1) of this subsection
11 available for Maryland small or independent film entities.

12 (ii) **FOR FISCAL YEAR 2023 AND EACH FISCAL YEAR**
13 **THEREAFTER, IN ADDITION TO THE AMOUNT SET ASIDE FOR MARYLAND SMALL OR**
14 **INDEPENDENT FILM ENTITIES UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE**
15 **SECRETARY SHALL MAKE 20% OF THE CREDIT AMOUNT AUTHORIZED UNDER**
16 **PARAGRAPH (1) OF THIS SUBSECTION AVAILABLE FOR FILM PRODUCTION**
17 **ACTIVITIES IN ANY OF THE FOLLOWING COUNTIES:**

- 18 1. **ALLEGANY COUNTY;**
- 19 2. **CAROLINE COUNTY;**
- 20 3. **DORCHESTER COUNTY;**
- 21 4. **GARRETT COUNTY;**
- 22 5. **KENT COUNTY;**
- 23 6. **PRINCE GEORGE'S COUNTY;**
- 24 7. **SOMERSET COUNTY;**
- 25 8. **WASHINGTON COUNTY; OR**
- 26 9. **WICOMICO COUNTY.**

27 (iii) [If the total amount of credits applied for by Maryland small or
28 independent film entities is less than the amount made available under subparagraph (i)

1 of this paragraph, the] **THE** Secretary shall make available the unused amount of credits
2 **UNDER THIS PARAGRAPH** for use by qualified film production entities **IF:**

3 **1. THE TOTAL AMOUNT OF CREDITS APPLIED FOR BY**
4 **MARYLAND SMALL OR INDEPENDENT FILM ENTITIES IS LESS THAN THE AMOUNT**
5 **MADE AVAILABLE UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH; OR**

6 **2. THE TOTAL AMOUNT OF CREDITS APPLIED FOR WITH**
7 **RESPECT TO FILM PRODUCTION ACTIVITIES IN THE COUNTIES IDENTIFIED IN**
8 **SUBPARAGRAPH (II) OF THIS PARAGRAPH IS LESS THAN THE AMOUNT MADE**
9 **AVAILABLE UNDER SUBPARAGRAPH (II) OF THIS PARAGRAPH.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
11 1, 2022.
