A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Sign Language Interpreters Act**

3 FOR the purpose of establishing a licensing and regulatory system for sign language
4 interpreters under the State Board of Sign Language Interpreters in the Office of the
5 Deaf and Hard of Hearing; and generally relating to the licensing of sign language
6 interpreters and the State Board of Sign Language Interpreters.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That Section(s) 8–403(58) through (62), respectively, of Article – State Government of the
6 Annotated Code of Maryland be renumbered to be Section(s) 8–403(59) through (63),
7 respectively.

8 SECTION 2. AND BE IT FURTHER ENACTED, That the new part designation
9 “Part II. Office of the Deaf and Hard of Hearing” be added to immediately precede Section
10 9–2402 of Article – State Government of the Annotated Code of Maryland.

20 (a) In this subtitle the following words have the meanings indicated.

21 **(B) “AMERICAN SIGN LANGUAGE” MEANS A VISUAL–SPATIAL METHOD OF**
22 **COMMUNICATION THAT IS A DISTINCT LANGUAGE INVOLVING THE HANDS, ARMS,**
23 **FACIAL MARKERS, AND BODY MOVEMENTS TO COMMUNICATE WITH OTHERS,**
24 **INCLUDING THROUGH THE CONVEYANCE OF THOUGHTS, WORDS, EMOTIONS, AND**
25 **GRAMMATICAL INFORMATION.**

26 **(C) “BEHAVIORAL HEALTH SETTING” MEANS A SETTING THAT PROVIDES:**

27 **(1) PSYCHIATRIC OR PSYCHOLOGICAL ASSESSMENT OR SCREENING;**

28 **(2) GROUP OR INDIVIDUAL PSYCHOTHERAPY, COUNSELING, OR**
29 **TREATMENT; OR**

30 **(3) REHABILITATION SERVICES FOR SUBSTANCE USE DISORDERS,**

1 ADDICTIVE DISORDERS, MENTAL DISORDERS, OR A COMBINATION OF THESE
2 DISORDERS.

3 (D) "BOARD" MEANS THE STATE BOARD OF SIGN LANGUAGE
4 INTERPRETERS WITHIN THE OFFICE.

5 [(b)] (E) "Council" means the Maryland Advisory Council on Deaf and Hard of
6 Hearing Individuals.

7 [(c)] (F) (1) "Deaf and hard of hearing individuals" means those residents of
8 Maryland who have a partial or complete loss of hearing.

9 (2) "Deaf and hard of hearing individuals" includes individuals who are
10 deaf, hard of hearing, deafblind, and late-deafened.

11 [(d)] (G) "Deafblind" means those residents of Maryland who have concomitant
12 vision and hearing loss.

13 [(e)] (H) "Director" means the Director of the Office.

14 (I) "FUND" MEANS THE SIGN LANGUAGE INTERPRETERS FUND.

15 (J) "HERITAGE SIGNER" MEANS AN INDIVIDUAL WHO USED AMERICAN
16 SIGN LANGUAGE AS A PRIMARY LANGUAGE IN CHILDHOOD.

17 (K) "LEGAL SETTING" INCLUDES:

18 (1) COURT PROCEEDINGS;

19 (2) ATTORNEY-CLIENT CONFERENCES;

20 (3) INVESTIGATIONS BY LAW ENFORCEMENT;

21 (4) DEPOSITIONS;

22 (5) WITNESS INTERVIEWS;

23 (6) REAL ESTATE SETTLEMENTS; AND

24 (7) ADMINISTRATIVE AND LEGISLATIVE HEARINGS.

25 (L) "LICENSE" MEANS A LICENSE ISSUED UNDER PART III OF THIS
26 SUBTITLE TO PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES.

1 (M) "MEDICAL SETTING" INCLUDES:

- 2 (1) AN ACUTE CARE HOSPITAL;
- 3 (2) AN URGENT CARE CENTER;
- 4 (3) AN OUTPATIENT CLINIC;
- 5 (4) SHORT-TERM CARE FACILITIES;
- 6 (5) LONG-TERM CARE FACILITIES;
- 7 (6) A PHYSICIAN'S OFFICE; AND
- 8 (7) HOME HEALTH CARE.

9 (N) "NATIONALLY OR REGIONALLY RECOGNIZED CERTIFICATION" MEANS:

10 (1) A CERTIFICATION ISSUED AND RECOGNIZED BY:

- 11 (I) THE NATIONAL ASSOCIATION OF THE DEAF (NAD);
- 12 (II) THE REGISTRY OF INTERPRETERS FOR THE DEAF (RID);

13 OR

- 14 (III) THE BOARD OF EVALUATION FOR INTERPRETERS (BEI);

15 OR

16 (2) ANY OTHER CERTIFICATION ISSUED BY A NATIONAL OR REGIONAL
17 ORGANIZATION THAT IS RECOGNIZED BY THE BOARD.

18 [(f)] (O) "Office" means the Office of the Deaf and Hard of Hearing.

19 (P) (1) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES" MEANS
20 TO CONVEY THE MEANING OF A MESSAGE THAT IS EXPRESSED IN:

21 (I) AN ORAL OR SIGNED LANGUAGE BY RENDERING THE
22 MESSAGE IN AMERICAN SIGN LANGUAGE; OR

23 (II) AMERICAN SIGN LANGUAGE BY RENDERING THE MESSAGE
24 IN AN ORAL OR SIGNED LANGUAGE.

25 (2) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES"

1 INCLUDES PROVIDING SIGN LANGUAGE INTERPRETATION SERVICES IN A VIDEO
2 REMOTE INTERPRETING SETTING.

3 (Q) "RESTORATIVE JUSTICE PROGRAM" MEANS A PROGRAM DESIGNED TO
4 REPAIR HARM CAUSED TO ALL INDIVIDUALS INVOLVED IN A CRIME THROUGH
5 MEDIATION, DIALOGUE, OR GROUP CONFERENCING BETWEEN A LICENSEE AND ANY
6 AGGRIEVED PARTY OR COMPLAINANT.

7 (R) "SCHOOL SETTING" MEANS A SETTING IN WHICH THE FOLLOWING IS
8 PROVIDED:

9 (1) EDUCATIONAL PROGRAMS OR SERVICES OFFERED BY A PUBLIC
10 OR NONPUBLIC SCHOOL; OR

11 (2) CAREER TRAINING PROGRAMS FOR SECONDARY EDUCATION
12 STUDENTS THAT ARE REGULATED BY THE STATE DEPARTMENT OF EDUCATION.

13 (S) "SIGN LANGUAGE INTERPRETER" MEANS AN INDIVIDUAL WHO IS
14 LICENSED BY THE BOARD TO PROVIDE SIGN LANGUAGE INTERPRETATION
15 SERVICES.

16 (T) "VIDEO RELAY SERVICE" MEANS THE FEDERALLY REIMBURSED AND
17 REGULATED PROGRAM ESTABLISHED TO ENABLE PHONE CALLS BETWEEN USERS OF
18 AMERICAN SIGN LANGUAGE AND INDIVIDUALS WHO DO NOT USE AMERICAN SIGN
19 LANGUAGE BY VIDEOCONFERENCING TECHNOLOGY AND THE USE OF THE SERVICES
20 OF A REMOTELY LOCATED SIGN LANGUAGE INTERPRETER.

21 (U) (1) "VIDEO REMOTE INTERPRETING SETTING" MEANS PROVIDING
22 SIGN LANGUAGE INTERPRETATION SERVICES BY VIDEOCONFERENCING IN WHICH
23 THE PARTICIPANTS ARE IN ONE LOCATION AND THE INTERPRETER IS IN A SEPARATE
24 LOCATION.

25 (2) "VIDEO REMOTE INTERPRETING SETTING" DOES NOT INCLUDE
26 VIDEO RELAY SERVICE.

27 9-2403.

28 (a) The Office shall be responsible for promoting the general welfare of deaf and
29 hard of hearing individuals in the State.

30 (b) The responsibilities of the Office shall include:

31 (1) providing, advocating, and coordinating the adoption of public policies,
32 regulations, and programs that will benefit deaf and hard of hearing individuals;

- 1 (2) improving access to communication and to existing services and
2 programs for deaf and hard of hearing individuals;
- 3 (3) providing direct services to deaf and hard of hearing individuals as
4 appropriate;
- 5 (4) increasing public awareness of the needs and issues affecting deaf and
6 hard of hearing individuals;
- 7 (5) working with State and local agencies to ensure access for deaf and hard
8 of hearing individuals to safety and emergency services;
- 9 (6) developing a referral service for deaf and hard of hearing individuals;
- 10 (7) serving as an information clearinghouse on the needs and issues
11 affecting deaf and hard of hearing individuals;
- 12 (8) working to increase access for deaf and hard of hearing individuals to
13 educational, health, and social opportunities;
- 14 (9) working with private organizations, the federal government, and other
15 units of State government to promote economic development for deaf and hard of hearing
16 individuals;
- 17 (10) working to eliminate the underemployment and unemployment of deaf
18 and hard of hearing individuals;
- 19 (11) providing a network through which services provided by State and
20 federal programs serving deaf and hard of hearing individuals can be channeled; [and]
- 21 (12) promoting compliance with State, local, and federal laws and policies
22 protecting and serving deaf and hard of hearing individuals;
- 23 **(13) PROVIDING APPROPRIATE STAFF TO ASSIST THE BOARD IN**
24 **CARRYING OUT ITS DUTIES; AND**
- 25 **(14) PROVIDING A NOMINATION PROCESS FOR BOARD APPOINTMENTS.**
- 26 (c) The Office shall hold at least two public town hall meetings each year to
27 receive public comments on:
- 28 (1) the quality of State services and programs affecting deaf and hard of
29 hearing individuals;
- 30 (2) the functions and operations of the Office; and

1 (3) any other issues that affect deaf and hard of hearing individuals,
2 including those specified in subsection (b) of this section.

3 (d) The Office shall:

4 (1) help facilitate the appropriate delivery of State, local, and other public
5 services to deaf and hard of hearing individuals;

6 (2) advise other units of State government and the General Assembly on
7 the needs of deaf and hard of hearing individuals;

8 (3) subject to appropriations in the State budget, provide any reasonable
9 resources that any other unit of State government requests to serve or assist deaf and hard
10 of hearing individuals; and

11 (4) to the greatest extent possible, in order to avoid any duplication of
12 effort, coordinate with other units of the State and the federal government the services
13 provided to deaf and hard of hearing individuals.

18 **THERE IS A STATE BOARD OF SIGN LANGUAGE INTERPRETERS IN THE**
19 **OFFICE.**

20 **9-2411.**

21 **(A) (1) THE BOARD CONSISTS OF SEVEN MEMBERS APPOINTED BY THE**
22 **GOVERNOR.**

23 **(2) OF THE SEVEN MEMBERS:**

24 **(I) ONE SHALL BE A MEMBER OF THE MARYLAND ASSOCIATION**
25 **OF THE DEAF;**

26 **(II) ONE SHALL BE A DEAFBLIND INDIVIDUAL;**

27 **(III) ONE SHALL BE A MEMBER OF THE POTOMAC CHAPTER OF**
28 **THE REGISTRY OF THE INTERPRETERS FOR THE DEAF WHO HOLDS A LICENSE**

1 UNDER THIS PART; AND

2 (IV) FOUR SHALL BE DETERMINED BY THE BOARD BY
3 REGULATION.

4 (3) (I) THE GOVERNOR SHALL APPOINT THE MEMBERS FROM A
5 LIST OF NAMES SUBMITTED FROM A NOMINATION PROCESS ESTABLISHED BY THE
6 OFFICE.

7 (II) TO THE EXTENT PRACTICABLE, THE MEMBERS APPOINTED
8 UNDER THIS SECTION SHALL REFLECT THE RACIAL AND GEOGRAPHIC DIVERSITY OF
9 THE STATE.

10 (B) EACH MEMBER SHALL:

11 (1) BE A RESIDENT OF THE STATE; AND

12 (2) BE PROFICIENT IN AMERICAN SIGN LANGUAGE.

13 (C) BEFORE TAKING OFFICE, EACH MEMBER APPOINTED TO THE BOARD
14 SHALL TAKE THE OATH OR AFFIRMATION REQUIRED BY ARTICLE I, § 9 OF THE
15 MARYLAND CONSTITUTION.

16 (D) (1) THE TERM OF A BOARD MEMBER IS 2 YEARS, BEGINNING ON THE
17 DATE OF APPOINTMENT.

18 (2) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL
19 A SUCCESSOR IS APPOINTED AND QUALIFIES.

20 (3) A MEMBER APPOINTED AFTER A TERM HAS BEGUN SERVES ONLY
21 FOR THE REMAINDER OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND
22 QUALIFIES.

23 (4) A MEMBER MAY NOT SERVE MORE THAN THREE CONSECUTIVE
24 FULL TERMS.

25 (E) (1) THE GOVERNOR MAY REMOVE A MEMBER FOR INCOMPETENCE,
26 MISCONDUCT, NEGLIGENCE OF DUTIES, OR OTHER SUFFICIENT CAUSE.

27 (2) THE GOVERNOR SHALL REMOVE A MEMBER WHO:

28 (I) CEASES TO MEET THE REQUIREMENTS UNDER WHICH THE
29 MEMBER WAS APPOINTED UNDER SUBSECTION (A) OF THIS SECTION; OR

1 (II) FAILS TO ATTEND AT LEAST 50% OF THE REGULARLY
2 SCHEDULED MEETINGS OF THE BOARD DURING ANY 12-MONTH PERIOD.

3 9-2412.

4 (A) (1) THE BOARD SHALL ELECT THE CHAIR FROM AMONG ITS
5 MEMBERS.

6 (2) THE TERM OF THE CHAIR IS 2 YEARS.

7 (B) (1) THE BOARD SHALL MEET AT LEAST ONCE EACH QUARTER AT THE
8 TIMES AND PLACES SET BY THE BOARD.

9 (2) THE BOARD MAY CALL SPECIAL MEETINGS AT THE REQUEST OF:

10 (I) THE CHAIR;

11 (II) THE DIRECTOR; OR

12 (III) A MAJORITY OF THE MEMBERS OF THE BOARD.

13 (C) A MAJORITY OF THE MEMBERS THEN SERVING ON THE BOARD IS A
14 QUORUM.

15 (D) A MEMBER OF THE BOARD:

16 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;
17 BUT

18 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
19 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

21 TO ENFORCE THE PROVISIONS OF THIS PART, THE BOARD MAY:

22 (1) IN CONSULTATION WITH THE OFFICE, CONDUCT INVESTIGATIONS
23 AND HOLD HEARINGS ON ANY MATTER COVERED BY THIS TITLE, AT ANY TIME AND
24 PLACE IN THE STATE;

25 (2) ADMINISTER OATHS;

1 **(3) EXAMINE WITNESSES; AND**

2 **(4) RECEIVE EVIDENCE.**

3 **9-2414.**

4 **(A) THE BOARD SHALL:**

5 **(1) LICENSE QUALIFIED INDIVIDUALS TO PROVIDE SIGN LANGUAGE**
6 **INTERPRETATION SERVICES;**

7 **(2) PROVIDE INFORMATION TO THE PUBLIC ABOUT SIGN LANGUAGE**
8 **INTERPRETER LICENSING REQUIREMENTS;**

9 **(3) PROVIDE TECHNICAL ASSISTANCE TO LICENSE APPLICANTS AND**
10 **OTHER INTERESTED PERSONS;**

11 **(4) PROMOTE THE PROFESSION OF SIGN LANGUAGE INTERPRETING,**
12 **INCLUDING PROVIDING WORKSHOPS AND TRAININGS TO RAISE PUBLIC AWARENESS**
13 **AND TO FACILITATE PROFESSIONAL DEVELOPMENT; AND**

14 **(5) PERFORM ANY OTHER DUTIES ASSIGNED BY THE DIRECTOR.**

15 **(B) IN ADDITION TO ANY DUTIES SET FORTH ELSEWHERE IN THIS SUBTITLE**
16 **AND WITH THE SUPPORT OF THE OFFICE, THE BOARD SHALL:**

17 **(1) ADMINISTER THE PROVISIONS OF THIS PART;**

18 **(2) ADOPT BYLAWS FOR THE CONDUCT OF ITS PROCEEDINGS;**

19 **(3) ADOPT A SEAL;**

20 **(4) KEEP A RECORD OF ITS PROCEEDINGS;**

21 **(5) KEEP A FILE ON EACH APPLICANT FOR A LICENSE;**

22 **(6) ESTABLISH A VISITING SIGN LANGUAGE INTERPRETER REGISTRY;**

23 **(7) DEVELOP AND MAINTAIN AN INTERNET PORTAL TO ACCEPT**
24 **LICENSE APPLICATIONS AND RELATED DOCUMENTATION, COMPLAINTS, AND**
25 **REGISTRATIONS OF VISITING SIGN LANGUAGE INTERPRETERS; AND**

26 **(8) REASONABLY SEEK ADDITIONAL FUNDING SOURCES.**

1 (C) IN ADDITION TO ANY POWERS SET FORTH ELSEWHERE, THE BOARD MAY
2 ADOPT REGULATIONS TO CARRY OUT THE PROVISIONS OF THIS PART.

4 (A) THE BOARD MAY ESTABLISH CRITERIA FOR THE DEVELOPMENT OF
5 PORTFOLIOS AND REQUIREMENTS IN THE FOLLOWING SPECIALIST AREAS:

6 (1) LEGAL SETTINGS;

7 (2) MEDICAL SETTINGS;

8 (3) BEHAVIORAL HEALTH SETTINGS;

9 (4) LANGUAGE PAIRS FOR OTHER THAN AMERICAN SIGN LANGUAGE
10 AND SPOKEN ENGLISH;

11 (5) CONFERENCE INTERPRETING;

12 (6) TACTILE AND LOW-VISION SIGN LANGUAGE INTERPRETATION
13 SERVICES;

14 (7) INTRALINGUISTIC TRANSLATIONS AND SIGN LANGUAGE
15 INTERPRETATION; AND

16 (8) ANY OTHER SPECIALIST AREAS DETERMINED TO BE NECESSARY
17 BY THE BOARD.

18 (B) THE BOARD SHALL ADOPT REGULATIONS TO:

19 (1) GOVERN SIGN LANGUAGE INTERPRETATION SERVICES PROVIDED
20 IN A VIDEO REMOTE INTERPRETING SETTING;

21 (2) ESTABLISH LICENSING AND CERTIFICATION STANDARDS OF
22 INTERPRETING AGENCIES THAT DO BUSINESS IN THE STATE;

23 (3) ALLOW DEAF AND HARD OF HEARING INDIVIDUALS TO
24 DETERMINE WHETHER THEY PREFER SIGN LANGUAGE INTERPRETATION SERVICES
25 BEING PROVIDED IN A VIDEO REMOTE INTERPRETING SETTING OR THROUGH
26 IN-PERSON INTERPRETING; AND

27 (4) PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES IN A VIDEO

1 REMOTE INTERPRETING SETTING.

3 (A) (1) THE BOARD SHALL MAINTAIN A LIST OF THE NAMES AND MAILING
4 ADDRESSES OF ALL LICENSEES, INCLUDING BY LICENSE TYPE.

5 (2) THE BOARD MAY RELEASE THE LIST OF NAMES TO THE PUBLIC.

6 (3) A LICENSEE SHALL DESIGNATE THE LICENSEE'S MAILING
7 ADDRESS AT THE TIME OF ISSUANCE ON THE ORIGINAL LICENSE AND ON THE
8 RENEWAL OF THE LICENSE.

9 (B) (1) ON REQUEST OF ANY PERSON AND RECEIPT OF PAYMENT OF A FEE
10 SET BY THE BOARD, THE BOARD SHALL CONFIRM THE LICENSE STATUS AND
11 QUALIFICATIONS OF ANY INDIVIDUAL WHO IS THE SUBJECT OF THE REQUEST.

12 (2) A CONFIRMATION UNDER PARAGRAPH (1) OF THIS SUBSECTION:

13 (I) SHALL INCLUDE A STATEMENT OF THE LICENSE STATUS OF
14 THE INDIVIDUAL WHO IS THE SUBJECT OF THE REQUEST; AND

15 (II) MAY INCLUDE:

16 1. INFORMATION ABOUT THE TRAINING, SPECIALIST
17 AREAS, AND OTHER QUALIFICATIONS OF THE INDIVIDUAL;

18 2. INFORMATION ABOUT THE DATES OF ISSUANCE OF
19 THE LICENSE OF THE INDIVIDUAL; AND

20 3. INFORMATION ABOUT ANY DISCIPLINARY ACTION
21 TAKEN AGAINST THE INDIVIDUAL.

23 (A) THERE IS A SIGN LANGUAGE INTERPRETERS FUND.

24 (B) (1) THE BOARD SHALL SET BY REGULATION REASONABLE FEES FOR
25 THE ISSUANCE AND RENEWAL OF LICENSES AND ITS OTHER SERVICES.

26 (2) THE FEES SHALL BE SET SO AS TO PRODUCE FUNDS TO
27 APPROXIMATE THE COST OF MAINTAINING THE BOARD.

1 **(C) THE BOARD SHALL PUBLISH IN ITS RULES AND REGULATIONS THE FEE**
2 **SCHEDULE SET BY THE BOARD.**

3 **(D) (1) THE BOARD SHALL PAY ALL FEES COLLECTED UNDER THIS PART**
4 **TO THE COMPTROLLER.**

5 **(2) THE COMPTROLLER SHALL DISTRIBUTE THE FEES TO THE FUND.**

6 **(E) THE FUND SHALL BE USED EXCLUSIVELY TO COVER THE ACTUAL**
7 **DOCUMENTED DIRECT AND INDIRECT COSTS OF FULFILLING THE STATUTORY AND**
8 **REGULATORY DUTIES OF THE BOARD AS PROVIDED BY THE PROVISIONS OF THIS**
9 **PART, INCLUDING:**

10 **(1) THE DEVELOPMENT OF PROGRAMS THAT WILL ASSIST IN THE**
11 **LICENSURE OF MARGINALIZED INTERPRETERS, INCLUDING:**
