2Criminal Procedure - Petition to Modify or Reduce Sentence3(Maryland Second Look Act)

4 FOR the purpose of authorizing a person who is serving a term of confinement to petition $\mathbf{5}$ a court to modify or reduce the sentence under certain circumstances; providing that 6 a certain petitioner is entitled to assistance of counsel and, under certain 7 circumstances, representation by the Office of the Public Defender; authorizing a 8 certain person to apply to the Court of Special Appeals for leave to appeal a certain 9 order in a certain manner and within a certain period of time after a court passes an order in accordance with the provisions of this Act; and generally relating to a 1011 petition to modify or reduce a life sentence.

1 (4) A PETITIONER MAY WAIVE THE RIGHT TO BE PRESENT AT A 2 HEARING HELD UNDER THIS SECTION.

3 (5) A COURT MAY NOT HOLD A HEARING UNDER THIS SECTION IF THE
4 COURT DETERMINES THAT THE PETITIONER IS NOT ELIGIBLE TO FILE A PETITION
5 UNDER SUBSECTION (A) OF THIS SECTION.

6 (C) (1) THE STATE'S ATTORNEY SHALL GIVE NOTICE TO EACH VICTIM 7 AND VICTIM'S REPRESENTATIVE WHO HAS FILED A CRIME VICTIM NOTIFICATION 8 REQUEST FORM UNDER § 11–104 OF THIS ARTICLE OR WHO HAS SUBMITTED A 9 WRITTEN REQUEST TO THE STATE'S ATTORNEY TO BE NOTIFIED OF SUBSEQUENT 10 PROCEEDINGS UNDER § 11–503 OF THIS ARTICLE:

11(I)THAT A PETITION TO MODIFY OR REDUCE A SENTENCE HAS12BEEN FILED UNDER THIS SECTION;

13(II)EITHER THAT THE PETITION HAS BEEN DENIED WITHOUT A14HEARING, OR OF THE DATE, TIME, AND LOCATION OF THE HEARING; AND

15(III) IF A HEARING IS TO BE HELD, THAT EACH VICTIM OR16VICTIM'S REPRESENTATIVE MAY ATTEND AND TESTIFY.

17 (2) A VICTIM OR A VICTIM'S REPRESENTATIVE IS ENTITLED TO AN
 18 OPPORTUNITY TO ATTEND AND TESTIFY IN THE MANNER PROVIDED BY MARYLAND
 19 RULE 4–345.

20 (D) A PETITIONER WHO HAS BEEN DETERMINED TO BE ELIGIBLE TO FILE A 21 PETITION UNDER SUBSECTION (A) OF THIS SECTION IS ENTITLED TO THE 22 ASSISTANCE OF COUNSEL AND, IF INDIGENT, TO REPRESENTATION BY THE OFFICE 23 OF THE PUBLIC DEFENDER.

24**(E)** (1) FOR A PETITIONER WHO WAS SENTENCED TO A TERM OF 25CONFINEMENT FOR AN OFFENSE THAT WAS COMMITTED WHEN THE PETITIONER WAS A MINOR, THE COURT SHALL MODIFY THE SENTENCE IN A MANNER 26REASONABLY CALCULATED TO RESULT IN THE PETITIONER'S RELEASE WITHIN 3 27YEARS IF THE COURT FINDS THAT THE PETITIONER HAS MATURED AND 2829**REHABILITATED SUCH THAT RETENTION OF THE SENTENCE IS NOT NECESSARY FOR** 30 THE PROTECTION OF THE PUBLIC.

31 (2) FOR A PETITIONER WHO WAS SENTENCED TO A TERM OF 32 CONFINEMENT WHEN THE PETITIONER WAS AT LEAST 18 YEARS OLD, THE COURT 33 MAY MODIFY THE SENTENCE IF THE COURT FINDS THAT RETENTION OF THE 34 SENTENCE IS NOT NECESSARY FOR THE PROTECTION OF THE PUBLIC. 1 (3) A COURT MAY NOT MODIFY OR REDUCE A SENTENCE UNDER THIS 2 SECTION UNLESS THE COURT GIVES THE STATE'S ATTORNEY AND EACH VICTIM OR 3 VICTIM'S REPRESENTATIVE WHO REQUESTS AN OPPORTUNITY TO BE HEARD THE 4 OPPORTUNITY TO OBJECT TO THE PETITION TO MODIFY OR REDUCE THE SENTENCE.

5 (4) A COURT MAY NOT INCREASE THE LENGTH OF A SENTENCE UNDER 6 THIS SECTION.

7 (F) WITHIN 30 DAYS AFTER THE COURT PASSES AN ORDER IN ACCORDANCE 8 WITH THIS SECTION, THE PETITIONER OR THE STATE MAY APPLY TO THE COURT OF 9 SPECIAL APPEALS FOR LEAVE TO APPEAL THE ORDER IN THE MANNER PROVIDED 10 BY MARYLAND RULE 8–204.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2022.
