CHAPTER _____

1 AN ACT concerning

2 **State Highway Administration – Pedestrian and Bicyclist Fatalities –**
3 **Infrastructure Review**
4 **(Vision Zero Implementation Act of 2022)**

5 FOR the purpose of requiring the State Highway Administration to conduct an
6 infrastructure review of each pedestrian or bicyclist fatality that occurs on a State
7 highway or at an intersection of a State highway and another highway or a municipal
8 street; requiring the Administration to complete the review within a certain number
9 of months after being notified by law enforcement of a pedestrian or bicyclist fatality
10 and publish the review on its website; requiring the Administration to publish a
11 certain assessment on the Administration’s website; and generally relating to
12 infrastructure reviews of pedestrian and bicyclist fatalities occurring on State
13 highways.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Transportation**

2 (A) THE ADMINISTRATION SHALL CONDUCT AN INFRASTRUCTURE REVIEW
3 OF EACH PEDESTRIAN OR BICYCLIST FATALITY THAT OCCURS:

4 (1) ON A STATE HIGHWAY; OR

5 (2) AT AN INTERSECTION OF A STATE HIGHWAY AND ANOTHER
6 HIGHWAY OR A MUNICIPAL STREET.

7 (B) THE ADMINISTRATION'S INFRASTRUCTURE REVIEW SHALL IDENTIFY:

8 (1) DEFICIENCIES IN ENGINEERING, TRAFFIC CONTROL, AND
9 TRAFFIC OPERATIONS; AND

10 (2) APPROPRIATE CORRECTIVE ACTIONS AND CRASH REDUCTION
11 COUNTERMEASURES THAT ARE CONSISTENT WITH THE ~~FEDERAL HIGHWAY~~

5 (C) IN CONDUCTING AN INFRASTRUCTURE REVIEW, THE ADMINISTRATION
6 SHALL CONSIDER:

7 (1) HIGHWAY CONTEXT, SUCH AS PROXIMITY OF THE HIGHWAY TO
8 MASS TRANSIT AND WHETHER THE HIGHWAY IS IN AN URBAN OR RURAL AREA;

9 (2) THE DIFFERENT MODES OF TRANSPORTATION USING THE
10 HIGHWAY, ~~INCLUDING THE PERCENTAGE WITH WHICH EACH MODE USES THE~~
11 ~~HIGHWAY; AND~~

12 (3) PRIOR CRASHES IN THE VICINITY.

13 (D) THE ADMINISTRATION SHALL:

14 (1) COMPLETE AN INFRASTRUCTURE REVIEW WITHIN 6 MONTHS
15 AFTER BEING NOTIFIED BY LAW ENFORCEMENT OF A PEDESTRIAN OR BICYCLIST
16 FATALITY; AND

17 (2) PUBLISH THE REVIEW ON ITS WEBSITE.

18 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 1,
19 2023, the State Highway Administration shall publish the vulnerable road user safety
20 assessment required under the Infrastructure Investment and Jobs Act, Public Law
21 117-58, on the State Highway Administration's website.

22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2022.
