5 FOR the purpose of requiring the State Highway Administration to conduct an 6 infrastructure review of each pedestrian or bicyclist fatality that occurs on a State 7 highway or at an intersection of a State highway and another highway or a municipal 8 street; requiring the Administration to complete the review within a certain number 9 of months after being notified by law enforcement of a pedestrian or bicyclist fatality 10 and publish the review on its website; requiring the Administration to publish a certain assessment on the Administration's website; and generally relating to 11 infrastructure reviews of pedestrian and bicyclist fatalities occurring on State 12 highways. 13
