2 Primary and Secondary Education – Title IX – Policies and Procedures 3 (Hear Our Voices Act of 2022)

FOR the purpose of requiring the State Board of Education to develop policies and procedures for reporting, administering, investigating, and resolving complaints related to incidents of sexual misconduct and violations of a certain federal law; authorizing a person to bring a civil action against a local system that fails to comply with certain policies and procedures and to recover damages, reasonable costs, and attorney's fees; and generally relating to sexual misconduct complaints and Title IX compliance.
