A BILL ENTITLED

1 AN ACT concerning

Declaration of Rights – Campaign Financing Right to Know

FOR the purpose of establishing that every individual has a right to know in an open, timely, and transparent manner about how, when, and by whom money is spent and from whom money is raised to influence the vote of the individual for candidates for office and ballot questions; and establishing that a publicly financed election is a right of the people.

Preamble

12 WHEREAS, The U.S. Constitution provides the people of this State a representative 13 government and guarantees the rights of free speech, assembly, and petition; and

14 WHEREAS, To fully exercise these rights of self-government, the public needs 15 information to choose candidates for office, decide ballot questions, and ensure that elected 16 officials are responsive to the people; and

WHEREAS, Our system of representative government depends in part on
guaranteeing that election campaigns are funded by and for the people and on eliminating
the corrupting and undemocratic effects of large private contributions; and

WHEREAS, The people have the right to know the source of the funds being spent to influence the State's elections and governmental actions; and

WHEREAS, That right includes transparency about how, when, and by and from whom significant funds are raised and spent to influence elections and governance; now, therefore,

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 (Three-fifths of all the members elected to each of the two Houses concurring), That it be 3 proposed that the Maryland Constitution read as follows:

Declaration of Rights

5 **ARTICLE 48.**

6 (A) THAT EVERY INDIVIDUAL HAS THE RIGHT TO KNOW INFORMATION IN AN 7 OPEN, TIMELY, AND TRANSPARENT MANNER ABOUT HOW, WHEN, AND BY WHOM 8 MONEY IS SPENT AND FROM WHOM MONEY IS RAISED TO INFLUENCE THE VOTE OF 9 THE INDIVIDUAL FOR CANDIDATES FOR OFFICE AND BALLOT QUESTIONS.

10 (B) THAT A PUBLICLY FINANCED ELECTION IS A RIGHT OF THE PEOPLE.

11 SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly 12 determines that the amendment to the Maryland Constitution proposed by Section 1 of this 13 Act affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the Maryland 14 Constitution concerning local approval of constitutional amendments do not apply.

15SECTION 3. AND BE IT FURTHER ENACTED, That the amendment to the 16Maryland Constitution proposed by Section 1 of this Act shall be submitted to the qualified 17voters of the State at the next general election to be held in November 2022 for adoption or rejection pursuant to Article XIV of the Maryland Constitution. At that general election, 18 19 the vote on the proposed amendment to the Constitution shall be by ballot, and on each 20ballot there shall be printed the words "For the Constitutional Amendment" and "Against the Constitutional Amendment", as now provided by law. Immediately after the election, 2122all returns shall be made to the Governor of the vote for and against the proposed 23amendment, as directed by Article XIV of the Maryland Constitution, and further 24proceedings had in accordance with Article XIV.
