1 AN ACT concerning

2Labor and Employment - Apprenticeships and Representation on the3Apprenticeship and Training Council - Representation

FOR the purpose of requiring that the Apprenticeship and Training Council and 4 consultants to the Council include representation by individuals who are Black and $\mathbf{5}$ Latino; establishing the Apprenticeship 2030 Commission to examine and make 6 7 recommendations to expand access to apprenticeship to reduce skill shortages in 8 high-demand occupations and provide affordable training for career pathways for young people to participate in apprenticeships in the public and private sectors; 9 requiring the Governor to include certain amounts in certain fiscal years in the 10 annual budget bill for a certain purpose; and generally relating to apprenticeships 11 12and representation on the Apprenticeship and Training Council.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 4 $\mathbf{5}$ That the Laws of Maryland read as follows: 6 **Article – Labor and Employment** 7 11 - 403.There is an Apprenticeship and Training Council as part of the Division 8 (b) (1)9 of Workforce Development and Adult Learning. The Council consists of 12 members all of whom shall be appointed by the Governor of Maryland, with the advice of the Secretary 10 and with the advice and consent of the Senate of Maryland. 11 12(2)Four of the members shall be representatives of employee 13organizations; one shall be an employee; five shall be representatives of employers; and two 14shall be appointed from the general public. 15(3)**(I)** The membership of the Council shall, to the extent practicable, 16reflect the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include representation by individuals with disabilities AND INDIVIDUALS WHO ARE 1718 BLACK AND LATINO. 19 **(II)** Consultants to the Council shall, to the extent practicable, reflect 20the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include 21representation by individuals with disabilities AND INDIVIDUALS WHO ARE BLACK AND 22LATINO. 23In advising the Governor, the Secretary shall give consideration to a (4)24balanced geographic representation from all of Maryland and a representative sampling 25and mix of Maryland industry. 26One member shall be appointed as Chairman by the Governor, with the (5)27advice of the Secretary, and serve as Chairman at the pleasure of the Governor. The 28Assistant State Superintendent, Career and Technology Education, and the Maryland 29State Director of the Office of Apprenticeship, U.S. Department of Labor, shall serve as 30 consultants to the Council without vote. 31The Governor, with the advice of the Secretary may appoint up to three (6)32additional consultants to the Council from the public at large. 2 SECTION 2 <u>4</u>. AND BE IT FURTHER ENACTED, That this Act shall take effect 3 October 1, 2022. Section 2 of this Act shall remain effective for a period of 1 year and 9 4 months and, at the end of June 30, 2024, Section 2 of this Act, with no further action 5 required by the General Assembly, shall be abrogated and of no further force and effect.
