A BILL ENTITLED

1 AN ACT concerning

2 **Police Officers – Education Requirements – Certification and Scholarships**

3 FOR the purpose of establishing certain degree requirements for certification and
4 recertification as a police officer; requiring law enforcement agencies to provide
5 work-related administrative leave to certain police officers and to develop and
6 implement certain recruitment policies; establishing the Continuing Education for
7 Police Officers Scholarship, the Police Officers Educational Benefit Scholarship I,
8 and the Police Officers Educational Benefit Scholarship II; and generally relating to
9 police officer certification and scholarships.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

14 (b) “Commission” means the Maryland Police Training and Standards
15 Commission.

17 (a) The Commission has the following powers and duties:

18 (20) **(I)** to evaluate and modernize recruitment standards and practices
19 of law enforcement agencies to increase diversity within those law enforcement agencies
20 and develop strategies for recruiting women and African American, Hispanic or Latino, and
21 other minority candidates; **AND**

22 **(II) TO REQUIRE LAW ENFORCEMENT AGENCIES TO DEVELOP**
23 **AND IMPLEMENT POLICIES FOR RECRUITMENT AT HISTORICALLY BLACK COLLEGES**
24 **AND UNIVERSITIES IN THE STATE;**

26 (a) The Commission shall certify as a police officer each individual who:

27 (3) submits to a criminal history records check in accordance with §
28 3–209.1 of this subtitle; [and]

29 **(4) HOLDS AN ASSOCIATE’S OR BACHELOR’S DEGREE IN ACCORDANCE**
30 **WITH § 3–209.3 OF THIS SUBTITLE; AND**

31 **[(4)] (5)** (i) is a United States citizen; or

2 resident of the United States and an honorably discharged veteran of the United States
3 armed forces, provided that the individual has applied to obtain United States citizenship

5 (b) (1) The certification of a police officer who fails to obtain United States
6 citizenship as required by subsection [(a)(4)(ii)] **(A)(5)(II)** of this section shall be
7 terminated by the Commission.

8 **(2) A POLICE OFFICER WHO FAILS TO OBTAIN A BACHELOR'S DEGREE**
9 **IN ACCORDANCE WITH § 3-209.3 OF THIS SUBTITLE MAY NOT BE RECERTIFIED BY**
10 **THE COMMISSION.**

12 **(A) IN THIS SECTION, "APPLICANT" MEANS AN INDIVIDUAL WHO IS SEEKING**
13 **CERTIFICATION AS A POLICE OFFICER.**

14 **(B) AN APPLICANT FOR CERTIFICATION AS A POLICE OFFICER SHALL AT**
15 **MINIMUM HOLD AN ASSOCIATE DEGREE.**

16 **(C) A POLICE OFFICER SHALL AT MINIMUM HOLD A BACHELOR'S DEGREE**
17 **WITHIN 6 YEARS OF BEING CERTIFIED.**

18 **(D) EACH LAW ENFORCEMENT AGENCY SHALL PROVIDE REASONABLE**
19 **WORK-RELATED ADMINISTRATIVE LEAVE, AS PROVIDED IN § 2-410 OF THIS**
20 **ARTICLE, TO A POLICE OFFICER WHO IS ATTEMPTING TO SATISFY THE DEGREE**
21 **REQUIREMENT UNDER SUBSECTION (C) OF THIS SECTION.**

22 **(E) (1) ON OR BEFORE APRIL 1, 2023, AND EACH YEAR THEREAFTER,**
23 **EACH LAW ENFORCEMENT AGENCY SHALL REPORT TO THE GOVERNOR'S OFFICE OF**
24 **CRIME PREVENTION, YOUTH, AND VICTIM SERVICES ON THE EDUCATION LEVEL OF**
25 **ALL POLICE OFFICERS EMPLOYED BY THE AGENCY.**

26 **(2) THE GOVERNOR'S OFFICE OF CRIME PREVENTION, YOUTH, AND**
27 **VICTIM SERVICES SHALL COMPILE THE INFORMATION REPORTED BY THE LOCAL**
28 **LAW ENFORCEMENT AGENCIES UNDER PARAGRAPH (1) OF THIS SUBSECTION AND**

14 **PUBLIC SAFETY ARTICLE.**15 **(D) “TECHNICAL INFRACTION” MEANS A MINOR RULE VIOLATION BY A**

4 (2) ACCEPTED FOR ADMISSION OR ENROLLED IN THE REGULAR
5 UNDERGRADUATE PROGRAM AT AN ELIGIBLE INSTITUTION; AND

6 (3) ATTEMPTING TO SATISFY THE DEGREE REQUIREMENT UNDER §
7 3-209.3(C) OF THE PUBLIC SAFETY ARTICLE.

8 (D) ALL APPLICANTS WHO FULFILL THE REQUIREMENTS ESTABLISHED IN
9 SUBSECTION (C) OF THIS SECTION SHALL RECEIVE A SCHOLARSHIP.

10 (E) A SCHOLARSHIP AWARDED UNDER THIS SECTION:

11 (1) MAY BE USED FOR THE TUITION AND FEES AT ANY ELIGIBLE
12 INSTITUTION FOR UP TO 60 CREDITS TOWARD A BACHELOR'S DEGREE; AND

13 (2) MAY BE UP TO 100% OF THE EQUIVALENT ANNUAL TUITION AND
14 FEES OF A RESIDENT UNDERGRADUATE STUDENT AT THE UNIVERSITY OF
15 MARYLAND, COLLEGE PARK CAMPUS.

17 (A) IN THIS SECTION, "SCHOLARSHIP" MEANS THE POLICE OFFICERS
18 EDUCATIONAL BENEFIT SCHOLARSHIP I.

19 (B) THERE IS A POLICE OFFICERS EDUCATIONAL BENEFIT SCHOLARSHIP
20 I.

21 (C) AN INDIVIDUAL MAY APPLY TO THE OFFICE FOR THE SCHOLARSHIP IF
22 THE INDIVIDUAL IS:

23 (1) A CURRENT OR FORMER CERTIFIED POLICE OFFICER WHO:

24 (I) HAS BEEN EMPLOYED IN THAT CAPACITY FOR A MINIMUM
25 OF 5 YEARS;

26 (II) IS A CURRENT RESIDENT OF THE STATE; AND

27 (III) HAS NOT BEEN REPRIMANDED FOR MISCONDUCT
28 EXCLUDING TECHNICAL INFRACTIONS; OR

1 **(2) A DEPENDENT CHILD OF A POLICE OFFICER UNDER ITEM (1) OF**
2 **THIS SUBSECTION, IF A SCHOLARSHIP HAS NOT ALREADY BEEN AWARDED UNDER**
3 **THIS SECTION TO THE POLICE OFFICER OR ANOTHER DEPENDENT CHILD OF THE**
4 **POLICE OFFICER.**

5 **(D) ALL APPLICANTS WHO FULFILL THE REQUIREMENTS ESTABLISHED IN**
6 **SUBSECTION (C) OF THIS SECTION SHALL RECEIVE A SCHOLARSHIP.**

7 **(E) A POLICE OFFICER IS NO LONGER ELIGIBLE TO APPLY FOR A**
8 **SCHOLARSHIP UNDER THIS SECTION IF THEIR DEPENDENT CHILD HAS APPLIED.**

9 **(F) A SCHOLARSHIP AWARDED UNDER THIS SECTION:**

10 **(1) MAY BE USED FOR THE TUITION AT ANY ELIGIBLE INSTITUTION**
11 **FOR UP TO 60 CREDITS; AND**

12 **(2) MAY BE UP TO 100% OF THE EQUIVALENT ANNUAL TUITION OF A**
13 **RESIDENT UNDERGRADUATE STUDENT AT THE UNIVERSITY OF MARYLAND,**
14 **COLLEGE PARK CAMPUS.**

16 **(A) IN THIS SECTION, "SCHOLARSHIP" MEANS THE POLICE OFFICERS**
17 **EDUCATIONAL BENEFIT SCHOLARSHIP II.**

18 **(B) THERE IS A POLICE OFFICERS EDUCATIONAL BENEFIT SCHOLARSHIP**
19 **II.**

20 **(C) AN INDIVIDUAL MAY APPLY TO THE OFFICE FOR THE SCHOLARSHIP IF**
21 **THE INDIVIDUAL IS:**

22 **(1) A CURRENT OR FORMER CERTIFIED POLICE OFFICER WHO:**

23 **(I) HAS BEEN EMPLOYED IN THAT CAPACITY FOR A MINIMUM**
24 **OF 10 YEARS;**

25 **(II) IS A CURRENT RESIDENT OF THE STATE;**

26 **(III) HAS NOT BEEN AWARDED THE CONTINUING EDUCATION**
27 **FOR POLICE OFFICERS SCHOLARSHIP UNDER § 18-3902 OF THIS SUBTITLE; AND**

1 (IV) HAS NOT BEEN REPRIMANDED FOR MISCONDUCT
2 EXCLUDING TECHNICAL INFRACTIONS; OR

3 (2) A DEPENDENT CHILD OF A POLICE OFFICER UNDER ITEM (1) OF
4 THIS SUBSECTION, IF A SCHOLARSHIP HAS NOT ALREADY BEEN AWARDED UNDER
5 THIS SECTION TO THE POLICE OFFICER OR ANOTHER DEPENDENT CHILD OF THE
6 POLICE OFFICER.

7 (D) ALL APPLICANTS WHO FULFILL THE REQUIREMENTS ESTABLISHED IN
8 SUBSECTION (C) OF THIS SECTION SHALL RECEIVE A SCHOLARSHIP.

9 (E) A POLICE OFFICER IS NO LONGER ELIGIBLE TO APPLY FOR A
10 SCHOLARSHIP UNDER THIS SECTION IF THEIR DEPENDENT CHILD HAS APPLIED.

11 (F) A SCHOLARSHIP AWARDED UNDER THIS SECTION:

12 (1) MAY BE USED FOR THE TUITION AT ANY ELIGIBLE INSTITUTION
13 FOR UP TO:

14 (I) 120 CREDITS; OR

15 (II) 60 CREDITS IF THE POLICE OFFICER OR A DEPENDENT
16 CHILD OF THE POLICE OFFICER WAS AWARDED THE POLICE OFFICERS
17 EDUCATIONAL BENEFIT SCHOLARSHIP I UNDER § 18-3903 OF THIS SUBTITLE; AND

18 (2) MAY BE UP TO 100% OF THE EQUIVALENT ANNUAL TUITION OF A
19 RESIDENT UNDERGRADUATE STUDENT AT THE UNIVERSITY OF MARYLAND,
20 COLLEGE PARK CAMPUS.

21 18-3905.

22 (A) THE COMMISSION MAY ADOPT ANY REGULATIONS NECESSARY TO
23 IMPLEMENT THIS SUBTITLE.

24 (B) THE OFFICE SHALL ESTABLISH THE APPLICATION AND AWARD
25 PROCESSES FOR THE SCHOLARSHIPS UNDER THIS SUBTITLE.

26 (C) FOR FISCAL YEAR 2024 AND EACH YEAR THEREAFTER, THE GOVERNOR
27 SHALL PROVIDE SUFFICIENT FUNDS IN THE BUDGET TO EQUAL 100% OF THE VALUE
28 OF THE SCHOLARSHIPS AWARDED UNDER THIS SUBTITLE.

29 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall be
30 construed to apply only prospectively and may not be applied or interpreted to have any
31 effect on or application to any police officers certified before the effective date of this Act.

1 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2022.
