BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 15 That the Laws of Maryland read as follows: 16 Article - Education 17 3-5B-01. 18 19 (a) The Frederick County Board consists of eight members as follows: 20 (1) Seven members elected from the county at large; and 21 (2)One nonvoting student member.

The terms of voting members are staggered as provided in subsection

- 27 FIRST FILL ANY VACANT POSITIONS FOR A FULL TERM OF 4 YEARS; AND
- 28 (II) AFTER ALL VACANT POSITIONS FOR A FULL TERM OF 4
- 29 YEARS ARE FILLED, THE CANDIDATE WITH THE NEXT HIGHEST VOTE TOTAL SHALL
- 30 FILL THE POSITION FOR WHICH A SUCCESSOR WAS APPOINTED UNDER PARAGRAPH
- 31 (3) OF THIS SUBSECTION AND SERVE THE REMAINDER OF THAT TERM.
- 32 (5) CANDIDATES FOR A VACATED OFFICE MAY BE NOMINATED AT A
- 33 PRIMARY ELECTION IN THE SAME MANNER AS ANY OTHER POSITION ON THE COUNTY
- 34 BOARD.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 2 $\,$ 1, 2022.
