## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Criminal Law – Threats to Public Officials**

3 FOR the purpose of ~~adding health officers, election administrators, and public employees~~  
4 ~~responsible for inspecting and enforcing housing and building codes and standards~~  
5 ~~to the list of public officials against whom it is illegal to make certain threats;~~  
6 altering the definition of “local official” as it applies to the prohibition on making  
7 certain threats to certain public officials; and generally relating to the prohibition on  
8 making or sending threats to public officials.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Criminal Law**

17 3–708.

18 (a) (1) In this section the following words have the meanings indicated.

1 (2) “Local official” means an individual serving in a publicly elected office  
 2 of a local government unit, as defined in § 10–101 of the State Government Article, **OR THE**  
 3 **CHIEF HEALTH OFFICER FOR A COUNTY.**

4 (3) (i) “State official” has the meaning stated in § 5–101 of the General  
 5 Provisions Article.

6 (ii) “State official” includes the Governor, Governor–elect,  
 7 Lieutenant Governor, and Lieutenant Governor–elect.

8 (4) “Threat” includes:

9 (i) an oral threat; or

10 (ii) a threat in any written form, whether or not the writing is signed,  
 11 or if the writing is signed, whether or not it is signed with a fictitious name or any other  
 12 mark.

13 (b) A person may not knowingly and willfully make a threat to take the life of,  
 14 kidnap, or cause physical injury to:

15 (1) a State official[.];

16 (2) a local official[.];

17 (3) a deputy State’s Attorney[.];

18 (4) an assistant State’s Attorney[, or]; **OR**

19 (5) an assistant Public Defender;

20 ~~(6) A HEALTH OFFICER;~~

21 ~~(7) AN ELECTION ADMINISTRATOR; OR~~

22 ~~(8) A PUBLIC EMPLOYEE RESPONSIBLE FOR INSPECTING AND~~  
 23 ~~ENFORCING HOUSING AND BUILDING CODES AND STANDARDS.~~

24 (c) A person may not knowingly send, deliver, part with, or make for the purpose  
 25 of sending or delivering a threat prohibited under subsection (b) of this section.

26 (d) A person who violates this section is guilty of a misdemeanor and on conviction  
 27 is subject to imprisonment not exceeding 3 years or a fine not exceeding \$2,500 or both.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
 29 1, 2022.
