12 13	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
14	Article – Election Law
15	9–310.
16	(a) (1) This subsection applies only to an absentee ballot that is sent by mail.
17 18	(2) (i) 1. An absentee ballot shall be enclosed in specially printed envelopes, the form and content of which shall be prescribed by the State Board.
19 20 21	2. THE FORM AND CONTENT PRESCRIBED UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH MAY NOT INCLUDE LANGUAGE OR INFORMATION THAT VISIBLY IDENTIFIES THE PARTY AFFILIATION OF THE VOTER.
22	(ii) The outgoing envelope shall include a statement, prominently

- placed, requesting that the recipient return the absentee ballot to the local board if the intended recipient no longer lives at that address.

 (3) (i) A local board may use either two envelopes or three envelopes.
- 4 (ii) If two envelopes are used, the inner envelope shall be designated 5 the "ballot/return envelope", and, when issued, it shall fit inside the envelope designated 6 the "outgoing envelope".
- 7 (iii) If three envelopes are used, the innermost envelope shall be 8 designated the "ballot envelope", which shall fit inside the envelope designated the "return 9 envelope", both of which, when issued, shall fit inside the envelope designated the "outgoing 10 envelope".
- 11 (iv) The ballot/return envelope
 - 11 (iv) The ballot/return envelope described under subparagraph (ii) of 12 this paragraph and the return envelope described under subparagraph (iii) of this 13 paragraph provided to a voter voting by absentee ballot:
 - 14 shall include prepaid postage; AND
 - 2. MAY NOT INCLUDE LANGUAGE OR INFORMATION
 16 THAT VISIBLY IDENTIFIES THE PARTY AFFILIATION OF THE VOTER.
 - 17 (4) (i) An absentee ballot shall be accompanied by instructions for 18 postage of the ballot/return envelope or the return envelope.
 - 19 (ii) The instructions for postage shall include:
 - 20 1. a statement that the ballot/return envelope or return 21 envelope includes prepaid postage and may be mailed as is; and
 - 22 2. directions for how a voter may attach postage for the 23 purpose of reducing the costs of the local board.
 - 24 (5) When voted and returned to the local board, an absentee ballot shall be 25 enclosed in a ballot envelope or ballot/return envelope, on which has been printed an oath 26 prescribed by the State Board.
 - 27 (b) The State Board shall reimburse each local board for 50% of the cost of prepaid 28 postage included on ballot/return envelopes or return envelopes provided to a voter voting 29 by absentee ballot under subsection **[**(a)(3)(iv)**] (A)(3)(IV)1** of this section.
 - 30 (c) (1) If an absentee ballot is sent by the Internet or facsimile transmission, 31 the local board shall provide the voter with an envelope template, the oath prescribed by 32 the State Board, and instructions for marking and returning the absentee ballot.

- 1 (2) AN ENVELOPE TEMPLATE PROVIDED UNDER PARAGRAPH (1) OF 2 THIS SUBSECTION MAY NOT INCLUDE LANGUAGE OR INFORMATION THAT VISIBLY 3 IDENTIFIES THE PARTY AFFILIATION OF THE VOTER.
- 4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June $5\,$ 1, 2022.
