# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

(f) This section may not be construed to require a written collaboration agreement between a nurse anesthetist and an anesthesiologist, a physician, or a dentist. 12 - 101."Authorized prescriber" means any licensed dentist, licensed dental hygienist (b) with prescriptive authority under § 4-206.4 of this article, licensed physician, licensed podiatrist, licensed veterinarian, advanced practice nurse with prescriptive authority under § 8-508 of this article, LICENSED NURSE ANESTHETIST, or other individual authorized by law to prescribe prescription or nonprescription drugs or devices. 12 - 102.(e) (1)This title does not prohibit: A dentist, physician, or podiatrist from administering a (i) prescription drug or device in the course of treating a patient; [or] (ii) A licensed dental hygienist from administering medication under § 4–206.4 of this article; OR (III) A NURSE FROM **ADMINISTERING** ANESTHETIST MEDICATION UNDER § 8–513 OF THIS ARTICLE. For the purposes of paragraph (1)(i) of this subsection, "administering" (2)means the direct introduction of a single dosage of a drug or device at a given time, whether by injection or other means, and whether in liquid, tablet, capsule, or other form. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2022.
