2 Transportation – Magnetic Levitation Transportation Systems – Rapid Rail 3 Local Development Councils

FOR the purpose of requiring a railroad company that acquires property by condemnation
for a magnetic levitation transportation system to pay a certain percentage of the
acquisition cost to a local development council; authorizing the governing body of
certain counties to establish a rapid rail local development council; requiring a rapid
rail local development council to distribute funds in a certain manner; and generally
relating to property acquired by condemnation for a magnetic levitation
transportation system.

SENATE BILL 1013

1 (a) A railroad company and the municipal corporation, public officer, or public 2 authority that owns or has control of any road, street, alley, or other public way or ground 3 necessary to locate any part of the railroad may agree on the manner, terms, and conditions 4 allowing the railroad company to use or occupy the road, street, alley, or other public way 5 or ground.

6 (b) (1) [If] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IF the 7 parties are unable to agree and the railroad company needs to use or occupy the road, street, 8 alley, or other public way or ground, the railroad company may acquire the property by 9 condemnation in accordance with Title 12 of the Real Property Article.

10 (2) Α RAILROAD COMPANY THAT ACQUIRES PROPERTY BY CONDEMNATION IN ACCORDANCE WITH TITLE 12 OF THE REAL PROPERTY ARTICLE 11 12FOR A MAGNETIC LEVITATION TRANSPORTATION SYSTEM LOCATED OR TO BE 13LOCATED IN THE STATE SHALL PAY AN ADDITIONAL AMOUNT EQUAL TO 25% of the 14ACQUISITION COST OF THE PROPERTY TO A RAPID RAIL LOCAL DEVELOPMENT COUNCIL ESTABLISHED IN ACCORDANCE WITH § 7–904 OF THE TRANSPORTATION 1516 ARTICLE.

17 (c) (1) A railroad company that lays track on any public street, road, alley, or 18 other public way or ground is responsible for any damage done by the location of the track 19 to private property on or near the public way or ground.

20 (2) The owner of the private property shall bring a civil action for damages 21 under this subsection within 2 years after the completion of the track.

(d) A railroad company may not pass through Baltimore City without the consentof the Mayor and City Council.

(A) THE GOVERNING BODY OF A COUNTY WHERE A RAILROAD COMPANY

5 (4) FOUR BUSINESS OWNERS, SELECTED BY THE GOVERNING BODY 6 OF THE COUNTY.

7 (C) (1) A RAPID RAIL LOCAL DEVELOPMENT COUNCIL SHALL DISTRIBUTE 8 FUNDS PAID TO THE COUNCIL UNDER § 5–407 OF THE PUBLIC UTILITIES ARTICLE 9 FOR COMMUNITY PROJECTS WITHIN A 5–MILE RADIUS OF A PROPERTY A RAILROAD 10 COMPANY ACQUIRES BY CONDEMNATION FOR A MAGNETIC LEVITATION 11 TRANSPORTATION SYSTEM LOCATED OR TO BE LOCATED IN THE STATE.

12(2)A RAPID RAIL LOCAL DEVELOPMENT COUNCIL MAY DISTRIBUTE13FUNDS TO:

- 14 (I) A NONPROFIT ORGANIZATION;
- 15 (II) A SCHOOL;
- 16 (III) A FAITH-BASED ORGANIZATION; OR

17 (IV) A COMMUNITY ASSOCIATION IN GOOD STANDING WITH THE 18 STATE DEPARTMENT OF ASSESSMENTS AND TAXATION.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 20 1, 2022.
