#### **10. Description and Purpose of Organization** (Limit length to visible area)

American Communities Trust (ACT) is a 501c3 public charity, whose mission is to create inclusive economic development projects that bring growth and prosperity to low-income residents. In Maryland, ACT intends to fill a gap by developing commercial properties, in close collaboration with resident leaders, that provide accessible employment in low-income neighborhoods. ACTs projects are in areas of high vacancy not served by traditional lending markets and that, as a result, require assembling tax credits and numerous private and public funding sources. As ACTs projects become fully realized, they are helping to positively transform neighborhoods by serving as anchors for employment and community activity. The new public space will engage residents and visitors while serving more than 800 weekly BaltimoreLINK riders (pre-pandemic count).

### 11. Description and Purpose of Project (Limit length to visible area)

The Last Mile: at N. Wolfe and N. Gay seeks to create a new landmark into the north-of-the-tracks neighborhoods of East Baltimore, while also positively transforming the Last Mile into Baltimore City. Bold artistic lighting and newly-painted walls at each underpass will advance a resident-led placemaking strategy by transforming dark, unsafe underpasses into vibrant, welcoming, and safe connectors that link communities north and south of the Amtrak rail line. This landmark will enhance safety and attract new residents and new visitors to several new developments underway north of the rail line. The landmark will also help connect residents in the north to amenities that are just south of the rail line.

#### 28. Comments

This project is a permanent artistic light installation. Based on a Memorandum of Understanding with Baltimore City, permanent artistic lighting (public art) is being installed underneath an underpass. American Communities Trust, Inc. will maintain the structure. Electricity for the art is provided from a site owned by American Communities Trust, Inc. BGE is installing a transformer on the privately owned site to power the public art.

A bold lighting design and new pocket park will help make Broadway East a destination and create a significant cultural landmark for Baltimore City. This type of placemaking strategy is important to counter community conditions including a 30 percent vacancy rate. Such conditions were not present in the communities where another, simpler lighting project was implemented in front of Mercy Medical Center on St. Paul Street. As a result, residents and ACT support a bolder design that will be a significant landmark for their community and for Baltimore City.

The great news is that Last Mile Park would help address many of the challenges this community is working hard to overcome. The Last Mile Park project is informed by research on the connection between health and the built environment and the theory of Crime Prevention through Environmental Design, which puts forward that environments can be designed to deter criminal behavior by improving "natural surveillance."

The more conservative spatially adjusted model indicated that a 10% increase in tree canopy was associated with a roughly 12% decrease in crime. When we broke down tree cover by public and private ownership for the spatial model, we found that the inverse relationship continued in both contexts, but the magnitude was 40% greater for public than for private lands." - -->"As this experimental study has shown, direct changes to vacant urban spaces may hold great promise in directly breaking the urban cycle of violence, fear, and abandonment and doing so in a cost-effective way that has broad, citywide scalability."
