AN ACT concerning

Congressional Districting Plan

FOR the purpose of establishing the composition of the eight districts in the State of Maryland for the election of members to the United States House of Representatives; requiring that a certain question be submitted to the qualified voters of the State if this Act is petitioned to referendum under Article XVI of the Maryland Constitution; and generally relating to the reconfiguration of congressional districts in the State.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 8–702 through 8–709 of Article – Election Law of the Annotated Code of Maryland be repealed.

SECTION 3. AND BE IT FURTHER ENACTED, That, if this Act is petitioned to referendum under Article XVI of the Maryland Constitution, a question substantially similar to the following shall be submitted to the qualified voters of the State:

“Question _____ – Congressional Districting Plan

Establishes the boundaries for the State's eight United States Congressional Districts based on recent census figures, as required by the United States Constitution.”.

SECTION 4. AND BE IT FURTHER ENACTED, That the General Assembly developed this Act pursuant to the Order of the Circuit Court for Anne Arundel County in Case No. C-02-CV-001816 and Case No. C-02-CV-001773, dated March 25, 2022. If the Circuit Court's judgment that Chapter 32 (House Bill 1) of the Acts of the General Assembly of the 2021 Special Session is unconstitutional is not upheld on appeal, or if the appeal is not otherwise dismissed, then this Act shall be void and of no further effect.

SECTION 5. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a ye and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
