(Senate Bill 741)

AN ACT concerning

Public Safety - Refrigerants - Limitations on Use

FOR the purpose of providing that, notwithstanding any other <u>provision of</u> law, regulation, or requirement, except for regulations issued by the Department of the Environment, <u>no provision of the State building code or other law or regulation may prohibit or otherwise limit</u> the use of a refrigerant may not be prohibited or otherwise limited if the refrigerant is designated as acceptable for use under federal listing requirements and any appliance containing the refrigerant meets federal safety standards and use conditions; and generally relating to the use of refrigerants in the State.

Article – Public Safety Section 12–706 Annotated Code of Maryland (2022 Replacement Volume)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Public Safety

12 - 706.

- (A) IN THIS SECTION, "APPLIANCE" MEANS ANY DEVICE THAT:
- (1) CONTAINS AND USES A CLASS I OR CLASS II SUBSTANCE, OR A SUBSTITUTE FOR A CLASS I OR CLASS II SUBSTANCE, AS DEFINED IN 42 U.S.C. 7671A, AS A REFRIGERANT; AND
- (2) IS USED FOR A HOUSEHOLD OR COMMERCIAL PURPOSE, INCLUDING AN AIR CONDITIONER, A REFRIGERATOR, A CHILLER, OR A FREEZER.
- (B) NOTWITHSTANDING ANY OTHER <u>PROVISION OF</u> LAW, REGULATION, OR REQUIREMENT IN THE STATE AND EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS <u>SECTION</u>, <u>EXCEPT FOR REGULATIONS ISSUED BY THE DEPARTMENT OF THE ENVIRONMENT, NO PROVISION OF THE STATE BUILDING CODE OR OTHER LAW OR REGULATION MAY PROHIBIT OR OTHERWISE LIMIT THE USE OF A REFRIGERANT MAY NOT BE PROHIBITED OR OTHERWISE LIMITED BY A BUILDING CODE OR OTHER REGULATION IN THE STATE IF:</u>

- (1) THE REFRIGERANT IS DESIGNATED AS ACCEPTABLE FOR USE IN ACCORDANCE WITH 42 U.S.C. 7671K; AND
- (2) ANY APPLIANCE CONTAINING THE REFRIGERANT DESIGNATED FOR ACCEPTABLE USE IS LABELED, INSTALLED, SERVICED, REPAIRED, USED, AND DISPOSED OF <u>INSTALLED AND USED</u> IN ACCORDANCE WITH THE SAFETY STANDARDS AND USE CONDITIONS UNDER 42 U.S.C. 7671<u>K.</u>
- (C) THIS SECTION DOES NOT PROHIBIT THE DEPARTMENT OF THE ENVIRONMENT FROM ADOPTING REGULATIONS THAT PROHIBIT THE USE OF A REFRIGERANT.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
