AMENDMENTS TO HOUSE BILL 290

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and White**” and substitute “**White, Pena-Melnyk, Cullison, Alston, Bhandari, Chisholm, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kerr, Kipke, R. Lewis, Lopez, Martinez, M. Morgan, Reilly, Rosenberg, and Woods**”; strike beginning with “parents” in line 3 down through “System” in line 4 and substitute “each county board of education”; in line 4, strike “or” and substitute “and”; strike beginning with the second “to” in line 5 down through “screening” in line 6 and substitute “notice to the parent or guardian of a child enrolled in the system or facility of the need for the child to receive a dental screening”; in line 7, strike “prohibitions and requirements” and substitute “a requirement”; and in line 8, strike “eligibility for dental service and the”.

On pages 1 and 2, strike in their entirety the lines beginning with line 25 on page 1 through line 1 on page 2, inclusive.

On page 2, in line 4, strike “and 15–152”.

AMENDMENT NO. 2

On page 2, in line 22, strike “(A)”; strike beginning with “THE” in line 22 down through “DENTIST” in line 24 and substitute “**EACH COUNTY BOARD SHALL PROVIDE:**”

**(1) NOTICE TO THE PARENT OR GUARDIAN OF AN ENROLLED CHILD OF THE CLINICAL NEED FOR THE CHILD TO RECEIVE A DENTAL SCREENING**”;

in lines 26, 27, and 28, strike “(1)”, “(2)”, and “(3)”, respectively, and substitute “(I)”, “(II)”, and “(III)”, respectively; in line 28, after “BIRTHDAY” insert “; AND”

**(2) THE NOTICE REQUIRED UNDER ITEM (1) OF THIS SECTION WITHIN 6 MONTHS BEFORE EACH BIRTHDAY LISTED IN ITEM (1) OF THIS SECTION**”;

and strike in their entirety lines 29 through 31, inclusive.

On page 3, in lines 1 and 17, in each instance, strike “(A)”; strike beginning with “THE” in line 1 down through “DENTIST” in line 4 and substitute “EACH FAMILY CHILD CARE HOME AND LARGE FAMILY CHILD CARE HOME SHALL PROVIDE:”

**(1) NOTICE TO THE PARENT OR GUARDIAN OF AN ENROLLED CHILD OF THE CLINICAL NEED FOR THE CHILD TO RECEIVE A DENTAL SCREENING**”;

in lines 5, 6, and 7, strike “(1)”, “(2)”, and “(3)”, respectively, and substitute “(I)”, “(II)”, and “(III)”, respectively; in line 7, after “BIRTHDAY” insert “; AND”

**(2) THE NOTICE REQUIRED UNDER ITEM (1) OF THIS SECTION WITHIN 6 MONTHS BEFORE EACH BIRTHDAY LISTED IN ITEM (1) OF THIS SECTION**”;

strike in their entirety lines 8 through 15, inclusive; strike beginning with “THE” in line 17 down through “DENTIST” in line 19 and substitute “EACH CHILD CARE CENTER SHALL PROVIDE:”

**(1) NOTICE TO THE PARENT OR GUARDIAN OF AN ENROLLED CHILD OF THE CLINICAL NEED FOR THE CHILD TO RECEIVE A DENTAL SCREENING**;

in lines 20, 21, and 22, strike “**(1)**”, “**(2)**”, and “**(3)**”, respectively, and substitute “**(I)**”, “**(II)**”, and “**(III)**”, respectively; in line 22, after “**BIRTHDAY**” insert “**;** **AND**”

**(2) THE NOTICE REQUIRED UNDER ITEM (1) OF THIS SECTION WITHIN 6 MONTHS BEFORE EACH BIRTHDAY LISTED IN ITEM (1) OF THIS SECTION**;

and strike lines 23 through 28, inclusive.

On pages 6 through 10, strike in their entirety the lines beginning with line 14 on page 6 through line 3 on page 10, inclusive, and substitute “**15-151.**”.

On page 10, strike beginning with the colon in line 4 down through “**ANNUALLY**” in line 8 and substitute “**ANNUALLY**”.

On page 12, after line 22, insert:

**SECTION 4. AND BE IT FURTHER ENACTED, That:**

**(a) The Maryland Department of Health shall conduct a study on providing reimbursement for services provided to a Maryland Medical Assistance Program recipient by a community health worker certified under § 13-3706 of the Health – General Article that:**

**(1) are covered by the Maryland Medical Assistance Program; and**

(2) assist the Maryland Medical Assistance Program recipient in accessing dental services.

(b) On or before December 1, 2024, the Department shall report its findings and recommendations to the Senate Finance Committee and the House Health and Government Operations Committee, in accordance with § 2-1257 of the State Government Article.”;

and in line 23, strike “4.” and substitute “5.”.
