AMENDMENTS TO HOUSE BILL 410
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Election Reform Act of 2023**” and substitute “**Elections – Polling Place Plan, Prohibited Acts, and 2024 Primary Election Date**”.

AMENDMENT NO. 2

On page 4, strike in their entirety lines 25 through 28, inclusive; and in line 29, strike “**(C)**” and substitute “**(B)**”.

On page 5, strike in their entirety lines 1 through 3, inclusive; in line 4, strike “**(2)**” and substitute “**(1)**”; in line 5, strike “**AND**”; after line 5, insert:

“**(2) AN ANALYSIS OF HOW TO MAXIMIZE VOTER PARTICIPATION IN EACH PRECINCT; AND**”;

in line 7, after “**PLACES**” insert “**BELOW THE TOTAL NUMBER OF SEPARATE BUILDINGS USED AS POLLING PLACES IN THE 2018 GENERAL ELECTION**”; strike beginning with “**DEMOGRAPHIC**” in line 10 down through “**PRECINCT**” in line 11 and substitute “**AN ANALYSIS OF AVAILABLE SUITABLE BUILDINGS WITHIN THE PRECINCT BOUNDARY, INCLUDING THE AVAILABILITY OF PARKING AND A DETERMINATION REGARDING BUILDING COMPLIANCE WITH THE FEDERAL AMERICANS WITH DISABILITIES ACT**”; in line 19, strike “**POPULATION DENSITY OF EACH**” and substitute “**PROXIMITY OF THE PROPOSED POLLING PLACE TO A DENSE CONCENTRATION OF VOTERS IN THE**”; strike beginning with the first “**THE**” in line 20 down through “**BUREAU**” in line 22 and substitute “**THE CHANGE IN THE NUMBER OF REGISTERED VOTERS IN THE AFFECTED PRECINCT FROM THE LAST**”

STATEWIDE ELECTION"; in line 26, after "ON" insert "THE ABILITY OF"; in line 27, after "COMMUNITIES" insert "TO CAST A BALLOT, INCLUDING DEMOGRAPHIC INFORMATION OF THE VOTERS IN THE AFFECTED PRECINCT FROM THE MOST RECENT REPORT PUBLISHED BY THE MARYLAND VITAL STATISTICS ADMINISTRATION"; in line 28, strike the "(D)" and substitute "(C)"; and in the same line, strike "MAY" and substitute "SHALL"; and in the same line, strike "ONLY".

On page 6, in line 5, strike "(E)" and substitute "(D)"; and in line 6, strike "(D)" and substitute "(C)".

On page 9, strike in their entirety lines 11 through 25, inclusive; and in lines 26 and 29, strike "3." and "4.", respectively, and substitute "2." and "3.", respectively.
